For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR STATE TURNBACK FOR
9 COUNTIES WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION TO
10 THOSE FUNDS APPROPRIATED BY ACT 417 OF 1993; AND FOR OTHER
11 PURPOSES."

Subtitle

14 "AN ACT FOR THE STATE TURNBACK FOR
15 COUNTIES SUPPLEMENTAL APPROPRIATION."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
20 Office of the Treasurer of State, to be payable from the County Aid Fund, for
21 the purpose of distributing General Revenue accruing therein for the benefit
22 of counties, as provided by law, by the Office of the Treasurer of State
23 which shall be supplemental and in addition to those funds appropriated in
24 Section 1 of Act 417 of 1993, the following:

30 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
31 authorized by this Act shall be limited to the appropriation for such agency
32 and funds made available by law for the support of such appropriations; and
33 the restrictions of the State Purchasing Law, the General Accounting and
34 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
35 Procedures and Restrictions Act, or their successors, and other fiscal

1 control laws of this State, where applicable, and regulations promulgated by
2 the Department of Finance and Administration, as authorized by law, shall be
3 strictly complied with in disbursement of said funds.

4

5 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
6 Assembly that any funds disbursed under the authority of the appropriations
7 contained in this Act shall be in compliance with the stated reasons for
8 which this Act was adopted, as evidenced by the Agency Requests, Executive
9 Recommendations and Legislative Recommendations contained in the budget
10 manuals prepared by the Department of Finance and Administration, letters, or
11 summarized oral testimony in the official minutes of the Arkansas Legislative
12 Council or Joint Budget Committee which relate to its passage and adoption.

13

14 SECTION 4. CODE. All provisions of this Act of a general and
15 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and
16 the Arkansas Code Revision Commission shall incorporate the same in the Code.

17

18 SECTION 5. SEVERABILITY. If any provision of this Act or the
19 application thereof to any person or circumstance is held invalid, such
20 invalidity shall not affect other provisions or applications of the Act which
21 can be given effect without the invalid provision or application, and to this
22 end the provisions of this Act are declared to be severable.

23

24 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
25 with this Act are hereby repealed.

26

27 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
28 Eightieth General Assembly that funds provided by the General Assembly for
29 the operations of the Office of the Treasurer of State are, due to unforeseen
30 circumstances, insufficient for the Office of the Treasurer of State to
31 continue to provide essential governmental services; that the provisions of
32 this act will provide the necessary monies for the Office of the Treasurer of
33 State to continue such services; and that a delay in the effective date of
34 this Act could work irreparable harm upon the proper administration and
35 provision of essential governmental programs. Therefore, an emergency is

1 hereby declared to exist and this Act being necessary for the immediate
2 preservation of the public peace, health and safety shall be in full force
3 and effect from and after the date of its passage and approval.
