11 IN ADDITION TO THOSE FUNDS APPROPRIATED BY ACT 1312 OF  
12 1993; AND FOR OTHER PURPOSES."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. EXTRA HELP - MATH AND SCIENCE SCHOOL. There is hereby authorized, for the Department of Education - General Education Division - Math and Science School, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated to the Department of Education - General Education Division for such purposes: five (5) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification, which such positions shall be supplemental and in addition to those positions authorized in Act 1312 of 1993.

SECTION 2. APPROPRIATIONS - MATH AND SCIENCE SCHOOL. There is hereby appropriated, to the Department of Education - General Education Division, to be payable from the Public School Fund, for personal services and operating expenses of the Department of Education - General Education Division - Math

16 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 17 authorized by this Act shall be limited to the appropriation for such agency  
 18 and funds made available by law for the support of such appropriations; and  
 19 the restrictions of the State Purchasing Law, the General Accounting and  
 20 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 21 Procedures and Restrictions Act, or their successors, and other fiscal  
 22 control laws of this State, where applicable, and regulations promulgated by  
 23 the Department of Finance and Administration, as authorized by law, shall be  
 24 strictly complied with in disbursement of said funds.

25

26 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General  
 27 Assembly that any funds disbursed under the authority of the appropriations  
 28 contained in this Act shall be in compliance with the stated reasons for  
 29 which this Act was adopted, as evidenced by the Agency Requests, Executive  
 30 Recommendations and Legislative Recommendations contained in the budget  
 31 manuals prepared by the Department of Finance and Administration, letters, or  
 32 summarized oral testimony in the official minutes of the Arkansas Legislative  
 33 Council or Joint Budget Committee which relate to its passage and adoption.

35 SECTION 5. CODE. All provisions of this Act of a general and

1 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and  
 2 the Arkansas Code Revision Commission shall incorporate the same in the Code.

4 SECTION 6. SEVERABILITY. If any provision of this Act or the  
 5 application thereof to any person or circumstance is held invalid, such  
 6 invalidity shall not affect other provisions or applications of the Act which  
 7 can be given effect without the invalid provision or application, and to this  
 8 end the provisions of this Act are declared to be severable.

9

10 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict  
 11 with this Act are hereby repealed.

12

13 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the  
 14 Eightieth General Assembly that funds provided by the General Assembly for  
 15 the operations of the Department of Education - General Education Division  
 16 are, due to unforeseen circumstances, insufficient for the Department of  
 17 Education - General Education Division to continue to provide essential  
 18 governmental services; that the provisions of this act will provide the  
 19 necessary monies for the Department of Education - General Education Division  
 20 to continue such services; and that a delay in the effective date of this Act  
 21 could work irreparable harm upon the proper administration and provision of  
 22 essential governmental programs. Therefore, an emergency is hereby declared  
 23 to exist and this Act being necessary for the immediate preservation of the  
 24 public peace, health and safety shall be in full force and effect from and  
 25 after the date of its passage and approval.
