For An Act To Be Entitled

8 "AN ACT TO PROVIDE FOR THE ERECTION OF A MEMORIAL ON THE
9 STATE CAPITOL GROUNDS HONORING WORKERS WHO HAVE GIVEN
10 THEIR LIVES WHILE IN THE COURSE OF THEIR EMPLOYMENT; AND
11 FOR OTHER PURPOSES."

Subtitle

14 "TO PROVIDE A MEMORIAL ON THE STATE
15 CAPITOL GROUNDS HONORING WORKERS WHO
16 HAVE GIVEN THEIR LIVES WHILE IN THE
17 COURSE OF THEIR EMPLOYMENT."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. (a) It is found and determined by the General Assembly that
22 unfortunately some workers have given their lives in the performance of their
23 duties for employers of this state; that these hardworking, taxpaying
24 citizens should be honored and an appropriate monument should be established
25 on the State Capitol grounds as a symbol of the recognition and appreciation
26 of this state to these individuals.

27 (b) The Secretary of State is authorized to set aside a location on
28 the State Capitol grounds for the purpose of constructing a memorial which
29 will honor those workers who have given their lives in the performance of
30 their jobs for the people of this state.

31 (c)(1) The Governor shall designate a representative from the Arkansas
32 AFL-CIO, the Arkansas unions representing industrial, construction, railroad
33 and public employees, along with a representative of employers who together
34 with the Secretary of State, shall constitute the Workers_ Memorial Design
35 Committee.

1 (2) The committee shall meet at such times as it shall determine
2 to be necessary to select a design and site for the memorial to be erected
3 and maintained on the State Capitol grounds. *The names of workers to be*
4 *honored shall not be listed on the memorial.*

5 (d)(1) The committee created by this section is authorized to accept
6 gifts, grants, and donations from individuals and organizations, which shall
7 be exclusively used to finance the construction of the memorial.

8 (2) The funds shall be deposited as trust funds in the Workers_
9 Memorial Fund which is hereby created on the books of the State Treasurer,
10 the State Auditor and the Chief Fiscal Officer of the State.

11 (3) Nothing in this section shall authorize the expenditure of
12 general revenue funds from the Treasury of the State.

13

14 SECTION 2. All provisions of this act of a general and permanent
15 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
16 Code Revision Commission shall incorporate the same in the Code.

17

18 SECTION 3. If any provision of this act or the application thereof to
19 any person or circumstance is held invalid, such invalidity shall not affect
20 other provisions or applications of the act which can be given effect without
21 the invalid provision or application, and to this end the provisions of this
22 act are declared to be severable.

23

24 SECTION 4. All laws and parts of laws in conflict with this act are
25 hereby repealed.
