## 7 For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE § 27-32-112 TO PROVIDE THAT  
9 INSPECTION CERTIFICATES FOR MOTORCYCLES BE PLACED IN AN  
10 APPROPRIATE SPACE ON THE LICENSE PLATE; TO AUTHORIZE THE  
11 DEPARTMENT OF ARKANSAS STATE POLICE TO REDESIGN THE MOTOR  
12 VEHICLE SAFETY INSPECTION DECAL FOR MOTORCYCLES TO COMPLY  
13 WITH THIS REQUIREMENT; AND FOR OTHER PURPOSES."

## 15 Subtitle

16 "AN ACT TO PROVIDE THAT INSPECTION  
17 CERTIFICATES FOR MOTORCYCLES BE PLACED  
18 IN AN APPROPRIATE SPACE ON THE LICENSE  
19 PLATE."

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23

24 SECTION 1. Arkansas Code § 27-32-112(d) is amended to read as follows:  
25 "(d) At the conclusion of each inspection of a motor vehicle by the  
26 person performing the inspection, the appropriate inspection certificate  
27 shall be placed in the lower left hand portion of the front windshield on the  
28 driver's side in a place that shall not obstruct the vision of the driver,  
29 except that, upon the inspection of a motorcycle, the inspection certificate  
30 shall be placed in the appropriate space on the license plate."

31

32 SECTION 2. *The Director of the Department of Arkansas State Police is  
33 authorized to make any necessary changes in the design of the motor vehicle  
34 safety inspection decals for motorcycles in order to comply with Arkansas  
35 Code § 27-32-112(d). The motor vehicle safety inspection decals for*

1   motorcycles shall be designed to fit within a space on the license plate  
2   designated for that purpose.

3           The Department shall make the design changes so to comply with these  
4   requirements effective with the issuance of inspection decals for the 1996  
5   calendar year.

7           SECTION 3. All provisions of this act of a general and permanent  
8   nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
9   Code Revision Commission shall incorporate the same in the Code.

10

11          SECTION 4. If any provision of this act or the application thereof to  
12   any person or circumstance is held invalid, such invalidity shall not affect  
13   other provisions or applications of the act which can be given effect without  
14   the invalid provision or application, and to this end the provisions of this  
15   act are declared to be severable.

16

17          SECTION 5. All laws and parts of laws in conflict with this act are  
18   hereby repealed.
