8 "AN ACT TO AMEND ARKANSAS CODE 7-5-105 AND 7-5-109 TO
9 ALTER THE FEE STRUCTURE FOR VOTER REGISTRATION LISTS; AND
10 FOR OTHER PURPOSES."

13 "TO ALTER THE FEE STRUCTURE FOR VOTER
14 REGISTRATION LISTS"
15

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
17

18 SECTION 1. Arkansas Code 7-5-105 is amended to read as follows:

19 "7-5-105. *Payment to county clerk for registered voter lists.*

20 (a) *The county clerks of the several counties of the state may*
21 *reproduce the registered voter list maintained by the county clerk in any*
22 *format that the office of the county clerk is capable of providing.*

23 (b) *The county clerks shall be entitled to a fee in connection with*
24 *the preparation of any registered voter list that shall reimburse the county*
25 *clerk for reproduction expenses. The value of office equipment previously*
26 *secured for the office of the county clerk shall not be considered when*
27 *determining the amount of this fee.*"
28

29 SECTION 2. Arkansas Code 7-5-109 is amended to read as follows:

30 "7-5-109. *Computerized voter registration lists.*

31 (a) *Every county clerk who maintains on computer the list of*
32 *registered voters within the county shall on request provide the list on*
33 *computer disk or tape. The list shall include at least the name, address and*
34 *precinct number of the voters.*

35 (b)(1) *The fee for a list, on computer disk or tape, of one (1) to*

1 *five thousand (5,000) registered voters shall be ten dollars (\$10.00).*

2 *(2) The fee for a list, on computer disk or tape, of five*
3 *thousand and one (5,001) to twenty-five thousand (25,000) registered voters*
4 *shall be twenty-five dollars (\$25.00).*

5 *(3) The fee for a list, on computer disk or tape, of more than*
6 *twenty-five thousand registered voters shall be fifty dollars (\$50.00)."*

7

8 *SECTION 3. All funds previously credited to the "Computerized Voter*
9 *Registration Fund" shall be used exclusively by the State Board of Election*
10 *Commissioners for funding a computerized statewide voter registration system.*

11

12 *SECTION 4. All provisions of this act of a general and permanent*
13 *nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas*
14 *Code Revision Commission shall incorporate the same in the Code.*

15

16 *SECTION 5. If any provision of this act or the application thereof to*
17 *any person or circumstance is held invalid, such invalidity shall not affect*
18 *other provisions or applications of the act which can be given effect without*
19 *the invalid provision or application, and to this end the provisions of this*
20 *act are declared to be severable.*

21

22 *SECTION 6. All laws and parts of laws in conflict with this act are*
23 *hereby repealed.*
