15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

         SECTION 1. Arkansas Code 7-5-401 is amended to read as follows:

         "7-5-401. Duties of county clerk.
18
         The county clerk shall be the custodian of the absentee and early
19
20 voting ballots. The county clerk shall be furnished a suitable room at the
21 county court-house and shall exercise all the powers and duties concerning
22 the application for, the issuance of, and the voting of absentee and early
23 voting ballots required by law of the county clerk."

         SECTION 2. Arkansas Code 7-5-402 is amended to read as follows:

         "7-5-402. Voter qualification.

         "7-5-403. Applications for ballots.

- (a) Applications for absentee ballots must be signed by the applicant 2 or, if sent by facsimile machine transmitted over telephone lines, must bear 3 a verifiable facsimile of the applicant's signature. Delivery of the request 4 for an absentee ballot to the county clerk may be made in one (1) of the 5 following ways, and in no other manner: (1) For applications submitted using the form prescribed in § 7-5-405: In person at the office of the county clerk of the 9 county of residence of the voter, no later than the time the county clerk s 10 office regularly closes on the day immediately preceding the day of the 11 election; (B) Applications by mail must be received in the office of 12 13 the county clerk of the county of residence of the voter not later than one 14 (1) day before the election for which the application was made. 15 (C) A relative or designated bearer may deliver the 16 completed application to the office of the county clerk of the county of 17 residence of the applicant not later than the time the county clerk s office 18 regularly closes on the day before the day of the election. Relative 19 includes husband, wife, son, son-in-law, daughter, daughter-in-law, sister, 20 sister-in-law, brother, brother-in-law, father, father-in-law, mother, 21 mother-in-law, grandparent, grandchild, aunt, uncle, niece, nephew, 22 great-grandparent, or great-grandchild of the applicant. A voter who is 23 homebound and having no relative in the county may designate any qualified 24 elector in the county to deliver the application; 25 (D) A person designated as the authorized agent of the 26 applicant may deliver the application to the office of the county clerk of 27 the county of residence of the applicant not later than 1:30 p.m. on the day 28 of the election. An authorized agent must submit to the county clerk an 29 affidavit of the administrative head of a hospital or nursing home located in 30 this state that the applicant is a patient in the hospital or nursing home 31 and is thereby unable to vote on the election day at his or her regular 32 voting place. A copy of the affidavit shall be retained by the county clerk
- 34 (E) An application for absentee ballot may be requested by 35 facsimile machine transmission in the county clerk's office and the clerk's

33 as an attachment to the application for an absentee ballot.

- 1 office may transmit the application form by facsimile machine transmission
- 2 over the telephone lines to applicants when the clerk's office is so
- 3 equipped. The completed faxed application must be received in the office
- 4 of the county clerk of the county of residence of the voter not later than

- 13 (A) A letter or postcard must be received in the office of
- 14 the county clerk not later than one (1) day before the date of the election.
- 15 The letter or postcard shall contain information sufficient to the county
- 16 board of election commissioners and the county clerk to accept the letter or
- 17 postcard in lieu of the application form.
- 18 (B) An applicant may transmit a written request for an
- 19 absentee ballot over the telephone lines which shall contain the voter's
- 20 signature and other information sufficient for acceptance in lieu of the
- 21 application form.
- 22 (b) Any person eligible to vote by absentee ballot may request the
- 23 county clerk to mail to an address within the continental United States an
- 24 application for an absentee ballot. The application shall remain in effect
- 25 for one (1) year unless revoked by the voter, and the county clerk shall
- 26 thereafter automatically mail, no later than twenty-five (25) days prior to
- 27 each election, an absentee ballot for each election.
- 28 (c) Citizens of the United States temporarily residing outside the
- 29 territorial limits of the United States and the District of Columbia, and
- 30 their spouses and dependents when residing with or accompanying them, may
- 31 request the absentee ballot for any one (1) or more elections during any one
- 32 (1) calendar year by submitting only one (1) application during that calendar
- 33 year in the manner prescribed by subsection (a) of this section."

        SECTION 6. Arkansas Code 7-5-413 is amended to read as follows:

        "7-5-413. Voting machines - Discretionary use - Related duties.
33
        (a) In any election in which voting machines are to be used in all or
34
35 part of the election precincts, the appropriate authority charged with
```

- 1 holding the election shall, within its discretion, determine by proper
- 2 resolution or order whether or not voting machines shall be used for absentee
- 3 or early voting by personal appearance at the election.
- 4 (b) If it is determined by that authority that voting machines shall
- 5 be used for absentee or early voting by personal appearance, a voting machine
- 6 or machines shall be placed in the office of the clerk who is to conduct the
- 7 absentee or early voting for the election in accordance with this subchapter.
- 8 The clerk shall follow the legal requirements for voting set forth in
- 9 Arkansas Constitution, Amendment 51 insofar as applicable to absentee or
- 10 early voting. Those persons entitled under the law to vote absentee or early
- 11 by personal appearance at the clerk's office shall cast their votes on voting
- 12 machines under the laws applicable to absentee or early voting, and the clerk
- 13 shall enter on a list the name of each voter at the time he votes.
- 14 (c) After the regular business hours, the clerk shall seal the
- 15 machines at the close of each day's voting in the presence of authorized poll
- 16 watchers, if any, and the seal shall be broken by the clerk in the presence
- 17 of the authorized watchers, if any, the following morning when the voting
- 18 begins. Voting absentee or early by machine will be concluded on the day
- 19 before election day at the time the county clerk's office regularly closes.
- 20 When absentee or early voting is concluded, the clerk shall lock and seal the
- 21 machines.
- 22 (d) At the time designated by law for the closing of the polls on
- 23 election day, a set of judges and clerks for the machines used for absentee
- 24 or early voting shall open the machines and canvass the vote in the manner
- 25 provided for regular polling places. After the canvass has been made, the
- 26 machines shall be locked and sealed and shall remain locked against voting
- 27 for the same period as required for other machines used in the election. The
- 28 results of the canvass shall be returned to the appropriate authority to be
- 29 tabulated and canvassed with and in the same manner as the returns of other
- 30 election precincts.
- 31 (e) Any candidate or political party may be present in person or by
- 32 representative designated in writing during the progress of absentee or early
- 33 voting and at the canvass of the results in any election for the purpose of
- 34 determining whether or not the votes in any election are fairly and
- 35 accurately cast and counted."

- 2 SECTION 7. Subchapter 4 of Chapter 5 of Title 7 is amended by adding 3 the following section:
- 4 "7-5-418. Early voting.
- 5 (a) Early voting shall be available to any qualified elector who 6 applies at the office of the County Clerk during regular office hours
- 7 beginning fifteen (15) days before an election and ending on the day before 8 election day at the time the County Clerk's office regularly closes.
- 9 (b) Before a person is permitted to cast an early vote, the county 10 clerk shall:
- 11 (1) Request the voter to identify himself by stating his *name*,
- 12 date of birth and address in order to verify his registration;
- 13 (2) If the voter's name or address is not the same as that in 14 the county voter registration record files, request the voter to complete an
- 15 updated voter registration application form;
- 16 (3) Request the voter to sign an early voting roster or early
- 17 voting request form and print his name, address and the date on the roster or
- 18 form.
- 19 (4) Enter the voter's precinct number on the early voting roster 20 or early voting request form.
- 21 (c) If the voter is not listed in the county voter registration record
- 22 file and the county clerk is unable to verify the voter's registration and
- 23 the voter contends that he or she is eligible to vote, then the voter may
- 24 vote a challenged ballot which shall only be counted upon verification of the
- 25 voter's registration status.
- 26 (d) The county clerk shall furnish voting locations that adequately
- 27 allows the early voter to personally and secretly execute his or her ballot.
- 28 (e) Upon casting his or her ballot, the voter shall then deposit the
- 29 ballot and the stub in the appropriate box in the same manner as for votes
- 30 cast on the day of the election.
- 31 (f) Early votes shall be maintained in the same manner and counted at 32 the same time as votes cast on the day of the election."

- 34 SECTION 8. All provisions of this act of a general and permanent
- 35 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas

1 Code Revision Commission shall incorporate the same in the Code.

         SECTION 9. If any provision of this act or the application thereof to

 4 any person or circumstance is held invalid, such invalidity shall not affect
 5 other provisions or applications of the act which can be given effect without
 6 the invalid provision or application, and to this end the provisions of this
 7 act are declared to be severable.

10 hereby repealed.
