HOUSE BILL 1660

For An Act To Be Entitled

"AN ACT TO AMEND ARKANSAS CODE 11-9-521 (a) CONCERNING
COMPENSATION FOR SCHEDULED PERMANENT INJURIES; AND FOR
OTHER PURPOSES."

Subtitle

"AN ACT CONCERNING COMPENSATION FOR
SCHEDULED PERMANENT INJURIES."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code 11-9-521 (a) is amended to read as follows:

"(a) An employee who sustains a permanent compensable injury scheduled in this section shall receive, in addition to compensation for temporary total and temporary partial benefits during the healing period or until the employee returns to work, whichever occurs first, weekly benefits in the amount of the permanent partial disability rate attributable to the injury, for that period of time set out in the following schedule;

(1) Arm amputated at the elbow, or between the elbow and shoulder, two hundred forty-two (242) weeks;

(2) Arm amputated between the elbow and wrist, one hundred eighty-two (182) weeks:

(3) Leg amputated at the knee, or between the knee and the hip, two hundred twelve (212) weeks;

(4) Leg amputated between the knee and the ankle, one hundred fifty-one (151) weeks;

(5) Hand amputated, one hundred eighty-two (182) weeks;

(6) Thumb amputated, seventy-eight (78) weeks;

(7) First finger amputated, forty-three (43) weeks;

1 (8) *Second finger amputated, thirty-seven (37) weeks;*
2 (9) *Third finger amputated, twenty-four (24) weeks;*
3 (10) *Fourth finger amputated, eighteen (18) weeks;*
4 (11) *Foot amputated, one hundred fifty-one (151) weeks;*
5 (12) *Great toe amputated, thirty-seven (37) weeks;*
6 (13) *Toe other than great toe amputated, thirteen (13) weeks;*
7 (14) *Eye Enucleated, in which there was useful vision, one hundred*
8 *twenty-one (121) weeks;*
9 (15) *Loss of hearing of one ear, forty-eight (48) weeks;*
10 (16) *Loss of hearing of both ears, one hundred eighty-two (182) weeks;*
11 (17) *Loss of one testicle, sixty-one (61) weeks; loss of both*
12 *testicles, one hundred eighty-two (182) weeks."*

14 SECTION 2. All provisions of this act of a general and permanent
15 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
16 Code Revision Commission shall incorporate the same in the Code.

18 SECTION 3. If any provision of this act or the application thereof to
19 any person or circumstance is held invalid, such invalidity shall not affect
20 other provisions or applications of the act which can be given effect without
21 the invalid provision or application, and to this end the provisions of this
22 act are declared to be severable.

24 SECTION 4. All laws and parts of laws in conflict with this act are
25 hereby repealed.
