8 "AN ACT TO AMEND AMENDMENT 51 § 5(c) OF THE ARKANSAS  
9 CONSTITUTION TO ALTER THE DUTIES OF THE STATE BOARD OF  
10 ELECTION COMMISSIONERS; AND FOR OTHER PURPOSES."

13 "TO AMEND AMENDMENT 51 § 5(c) OF THE  
14 ARKANSAS CONSTITUTION TO ALTER THE  
15 DUTIES OF THE STATE BOARD OF ELECTION  
16 COMMISSIONERS"

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 SECTION 1. Pursuant to the authority granted in Amendment 51 § 19,  
21 Amendment 51 § 5(c) is amended to read as follows:

22 "(c) The State Board of Election Commissioners is authorized and, as  
23 soon as is possible after the effective date of this amendment, directed to  
24 prescribe, adopt, publish and distribute:

25 (1) such Rules and Regulations supplementary to this amendment  
26 and consistent with this amendment and other laws of Arkansas as are  
27 necessary to secure uniform and efficient procedures in the administration of  
28 this amendment throughout the State;

29 (2) a current copy of all election laws in a bound volume to  
30 each member of the county board of registration and the county clerk of each  
31 of the several counties of the state; and

32 (3) detailed specifications of the Registration Record Files,  
33 the Affidavits of Registration and other registration forms, all of which  
34 shall be consistent with this amendment and uniform throughout the State."

35

1        SECTION 2. All provisions of this act of a general and permanent  
2 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
3 Code Revision Commission shall incorporate the same in the Code.

5        SECTION 3. If any provision of this act or the application thereof to  
6 any person or circumstance is held invalid, such invalidity shall not affect  
7 other provisions or applications of the act which can be given effect without  
8 the invalid provision or application, and to this end the provisions of this  
9 act are declared to be severable.

10

11        SECTION 4. All laws and parts of laws in conflict with this act are  
12 hereby repealed.
