## For An Act To Be Entitled

7 "AN ACT TO AMEND ARKANSAS CODE 21-6-307(b) TO CHANGE THE  
8 NAME OF THE SHERIFF\_S RADIO AND EQUIPMENT REPAIR AND  
9 REPLACEMENT FUND TO THE COMMUNICATIONS FACILITY AND  
10 EQUIPMENT FUND; TO EXPEND THE PURPOSES FOR WHICH THE FUND  
11 CAN BE USED; AND FOR OTHER PURPOSES."

### Subtitle

13  
14 "TO CHANGE THE NAME OF THE SHERIFF\_S  
15 RADIO AND EQUIPMENT REPAIR AND  
16 REPLACEMENT FUND TO THE COMMUNICATIONS  
17 FACILITY AND EQUIPMENT FUND."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. Arkansas Code 21-6-307(b) is amended to read as follows:  
22 "(b)(1) Seventy-five percent (75%) of all fees collected by the  
23 sheriff shall be paid into the county treasury in the manner provided by law,  
24 or to the person entitled to receive the money or his order or his attorney  
25 of record.

26  
27 (2) The remaining twenty-five percent (25%) of all fees collected  
28 by the sheriff shall be used by the sheriff to establish a special fund to be  
29 known as the Communications Facility and Equipment Fund.

30  
31 (A) All funds so designated shall be invested by the sheriff in  
32 an interest-bearing account or certificate of deposit in one (1) or more  
33 banking institutions domiciled within the State of Arkansas and insured by  
the Federal Deposit Insurance Corporation.

34  
35 (B) All sums paid into the Communications Facility and Equipment  
Fund by the sheriff may accumulate as to principal and interest until such

1 time as the deposits or a portion thereof are needed by the sheriff to train  
2 operations staff, to operate, equip, repair or replace existing  
3 communications equipment, to purchase additional communications equipment, or  
4 to otherwise improve a communications facility or system for the sheriff's  
5 department."

7         SECTION 2. All provisions of this act of a general and permanent  
8 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
9 Code Revision Commission shall incorporate the same in the Code.

10

11         SECTION 3. If any provision of this act or the application thereof to  
12 any person or circumstance is held invalid, such invalidity shall not affect  
13 other provisions or applications of the act which can be given effect without  
14 the invalid provision or application, and to this end the provisions of this  
15 act are declared to be severable.

16

17         SECTION 4. All laws and parts of laws in conflict with this act are  
18 hereby repealed.
