7 "AN ACT TO INCREASE CONSTRUCTION COST LIMITS UNDER WHICH
8 PUBLIC SCHOOL BUILDINGS AND OTHER PUBLIC WORKS WILL
9 QUALIFY FOR EXEMPTIONS UNDER ARK. CODE §§ 17-14-302 AND
10 22-9-101; AND FOR OTHER PURPOSES."

14 "TO INCREASE CONSTRUCTION COST LIMITS
15 UNDER WHICH PUBLIC SCHOOL BUILDINGS
16 QUALIFY FOR EXEMPTIONS UNDER A.C.A.
17 §§ 17-14-302 AND 22-9-101."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. Arkansas Code Annotated § 17-14-302(b) is hereby amended to
22 read as follows:

23 "(b)(1) The terms of this chapter shall not apply to:

24 (A) Any public school district exempted from the
25 provisions of this chapter; or

26 (B) Every public school district embracing a city with a
27 population in excess of thirty thousand (30,000), which maintains a full-time
28 superintendent of buildings with engineering and architectural experience.

29 (2) This exception shall only apply:

30 (A) To the repair and maintenance of buildings already
31 constructed and alterations thereof; and

32 (B) To new structures that will not exceed in cost the sum
33 of one hundred thousand dollars (\$100,000)."

34

35 SECTION 2. Arkansas Code Annotated § 17-14-302(c) is hereby amended to

1 read as follows:

2 "(c) The provisions of this chapter shall not apply to any public
3 school district where the cost of the building, alteration, or structure does
4 not exceed the sum of one hundred thousand dollars (\$100,000)."

5

6 SECTION 3. Arkansas Code Annotated § 22-9-101(b) is hereby amended to
7 read as follows:

8 "(b) Nothing in this section shall be held to apply to any public
9 works wherein the contemplated construction expenditure for an engineering
10 project does not exceed twenty-five thousand dollars (\$25,000) or for an
11 architectural project does not exceed one hundred thousand dollars
12 (\$100,000)."

13

14 SECTION 4. All provisions of this act of a general and permanent
15 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
16 Code Revision Commission shall incorporate the same in the Code.

17

18 SECTION 5. If any provision of this act or the application thereof to
19 any person or circumstance is held invalid, such invalidity shall not affect
20 other provisions or applications of the act which can be given effect without
21 the invalid provision or application, and to this end the provisions of this
22 act are declared to be severable.

23

24 SECTION 6. All laws and parts of laws in conflict with this act are
25 hereby repealed.
