1857

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION TO THE STATE MILITARY
9 DEPARTMENT FOR CONSTRUCTION, CAPITAL EQUIPMENT, AND OTHER
10 COSTS INCURRED AT VARIOUS ARMORIES AND FACILITIES; AND FOR
11 OTHER PURPOSES."

Subtitle

14 "AN ACT FOR THE STATE MILITARY
15 DEPARTMENT CAPITAL IMPROVEMENT
16 APPROPRIATION."

17

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the State
21 Military Department, to be payable from the General Improvement Fund or its
22 successor fund or fund accounts, the following:

23 (A) For the purchase of termite and pest control contracts, the sum of
24 \$400,000.

25

26 (B) For constructing and equipping a National Guard Armory in Searcy,
27 Arkansas, the sum of \$1,223,276.

28

29 (C) For constructing and equipping a National Guard Armory in Benton,
30 Arkansas, the sum of \$837,570.

31

32 (D) For constructing and equipping the National Guard Armory in
33 Warren, Arkansas, the sum of \$983,805.

34

35 (E) For constructing and equipping a National Guard Armory and

1 Organizational Maintenance Shop in Hazen, Arkansas, the sum of ... \$666,000.

2

3 SECTION 2. APPROPRIATIONS - FEDERAL. There is hereby appropriated, to
4 the State Military Department, to be payable from the federal funds as
5 designated by the Chief Fiscal Officer of the State, the following:

6 (A) For constructing and equipping the National Guard Armory in
7 Searcy, Arkansas, the sum of \$2,854,312.

8

9 (B) For constructing and equipping the National Guard Organizational
10 Maintenance Shop in Warren, Arkansas, the sum of \$1,373,986.

11

12 (C) For constructing and equipping the National Guard Armory in
13 Benton, Arkansas, the sum of \$1,954,329.

14

15 (D) For constructing and equipping the Army Aviation Support Facility
16 at Camp Robinson, Arkansas, the sum of \$11,760,624.

17

18 (E) For constructing and equipping the National Guard Armory in
19 Warren, Arkansas, the sum of \$2,295,545.

20

21 (F) For constructing and equipping a National Guard Armory and
22 Organizational Maintenance Shop in Hazen, Arkansas, the sum of .. \$3,147,000.

23

24 (G) For constructing and equipping a National Guard Military
25 Operations in Urban Terrain (MOUT) Training Facility, the sum of \$3,575,560.

26

27 (H) For constructing and equipping a National Guard Combined Support
28 Maintenance Shop in Fayetteville, Arkansas, the sum of \$1,970,520.

29

30 (I) For constructing and equipping a National Guard Combined Support
31 Maintenance Shop at Camp Robinson, Arkansas, the sum of \$11,100,724.

32

33 (J) For constructing and equipping an Ammunition Supply Point at Camp
34 Robinson, Arkansas, the sum of \$3,544,800.

35

1 (K) For major maintenance, renovation, and repair of the Army Aviation
2 Airstrip at Camp Robinson, Arkansas, the sum of \$945,158.

3

4 (L) For constructing and equipping the National Guard Organizational
5 Maintenance Shop in Jonesboro, Arkansas, the sum of \$1,970,520.

6

7 (M) For constructing and equipping the National Guard Organizational
8 Maintenance Shop at Camp Robinson, Arkansas, the sum of \$1,373,986.

9

10 SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
11 obligations otherwise incurred in relation to the project or projects
12 described herein in excess of the State Treasury funds actually available
13 therefor as provided by law. Provided, however, that institutions and
14 agencies listed herein shall have the authority to accept and use grants and
15 donations including Federal funds, and to use its unobligated cash income or
16 funds, or both available to it, for the purpose of supplementing the State
17 Treasury funds for financing the entire costs of the project or projects
18 enumerated herein. Provided further, that the appropriations and funds
19 otherwise provided by the General Assembly for Maintenance and General
20 Operations of the agency or institutions receiving appropriation herein shall
21 not be used for any of the purposes as appropriated in this Act.

22 (B) The restrictions of any applicable provisions of the State
23 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
24 Revenue Stabilization Law and any other applicable fiscal control laws of
25 this State and regulations promulgated by the Department of Finance and
26 Administration, as authorized by law, shall be strictly complied with in
27 disbursement of any funds provided by this Act unless specifically provided
28 otherwise by law.

29

30 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
31 Assembly that any funds disbursed under the authority of the appropriations
32 contained in this Act shall be in compliance with the stated reasons for
33 which this Act was adopted, as evidenced by the Agency Requests, Executive
34 Recommendations and Legislative Recommendations contained in the budget
35 manuals prepared by the Department of Finance and Administration, letters, or

1 summarized oral testimony in the official minutes of the Arkansas Legislative
2 Council or Joint Budget Committee which relate to its passage and adoption.

3

4 SECTION 5. CODE. All provisions of this Act of a general and
5 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and
6 the Arkansas Code Revision Commission shall incorporate the same in the Code.

7

8 SECTION 6. SEVERABILITY. If any provision of this Act or the
9 application thereof to any person or circumstance is held invalid, such
10 invalidity shall not affect other provisions or applications of the Act which
11 can be given effect without the invalid provision or application, and to this
12 end the provisions of this Act are declared to be severable.

13

14 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
15 with this Act are hereby repealed.

16

17 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
18 Eightieth General Assembly, that the Constitution of the State of Arkansas
19 prohibits the appropriation of funds for more than a two (2) year period;
20 that the effectiveness of this Act on July 1, 1995 is essential to the
21 operation of the agency for which the appropriations in this Act are
22 provided, and that in the event of an extension of the Regular Session, the
23 delay in the effective date of this Act beyond July 1, 1995 could work
24 irreparable harm upon the proper administration and provision of essential
25 governmental programs. Therefore, an emergency is hereby declared to exist
26 and this Act being necessary for the immediate preservation of the public
27 peace, health and safety shall be in full force and effect from and after
28 July 1, 1995.
