7 "AN ACT TO MAKE AN APPROPRIATION FOR LOANS AND/OR
8 SCHOLARSHIPS OF THE RURAL MEDICAL PRACTICE STUDENT LOAN
9 AND SCHOLARSHIP PROGRAM AND THE COMMUNITY MATCH STUDENT
10 LOAN AND SCHOLARSHIP PROGRAM; ALL AS MAY BE AUTHORIZED BY
11 LAW, FOR THE UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES
12 FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1997; AND FOR
13 OTHER PURPOSES."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
24 University of Arkansas for Medical Sciences, to be payable from the State
25 General Services Fund Account, for loans and/or scholarships of the Rural
26 Medical Practice Student Loan and Scholarship Program and the Community Match
27 Student Loan and Scholarship Program all as may be authorized by law, for the
28 University of Arkansas for Medical Sciences for the biennial period ending
29 June 30, 1997, the following:

4 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
5 authorized by this Act shall be limited to the appropriation for such agency
6 and funds made available by law for the support of such appropriations; and
7 the restrictions of the State Purchasing Law, the General Accounting and
8 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
9 Procedures and Restrictions Act, the Higher Education Expenditure
10 Restrictions Act, or their successors, and other fiscal control laws of this
11 State, where applicable, and regulations promulgated by the Department of
12 Finance and Administration, as authorized by law, shall be strictly complied
13 with in disbursement of said funds.

15 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
16 Assembly that any funds disbursed under the authority of the appropriations
17 contained in this Act shall be in compliance with the stated reasons for
18 which this Act was adopted, as evidenced by the Agency Requests, Executive
19 Recommendations and Legislative Recommendations contained in the budget
20 manuals prepared by the Department of Finance and Administration, letters, or
21 summarized oral testimony in the official minutes of the Arkansas Legislative
22 Council or Joint Budget Committee which relate to its passage and adoption.

23

24 SECTION 4. CODE. All provisions of this Act of a general and
25 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and
26 the Arkansas Code Revision Commission shall incorporate the same in the Code.

27

28 SECTION 5. SEVERABILITY. If any provision of this Act or the
29 application thereof to any person or circumstance is held invalid, such
30 invalidity shall not affect other provisions or applications of the Act which
31 can be given effect without the invalid provision or application, and to this
32 end the provisions of this Act are declared to be severable.

33

34 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
35 with this Act are hereby repealed.

2 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
3 Eightieth General Assembly, that the Constitution of the State of Arkansas
4 prohibits the appropriation of funds for more than a two (2) year period;
5 that the effectiveness of this Act on July 1, 1995 is essential to the
6 operation of the agency for which the appropriations in this Act are
7 provided, and that in the event of an extension of the Regular Session, the
8 delay in the effective date of this Act beyond July 1, 1995 could work
9 irreparable harm upon the proper administration and provision of essential
10 governmental programs. Therefore, an emergency is hereby declared to exist
11 and this Act being necessary for the immediate preservation of the public
12 peace, health and safety shall be in full force and effect from and after
13 July 1, 1995.
