7 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED § 20-13-807 TO
8 INCLUDE MEMBERS OF THE ARKANSAS GENERAL ASSEMBLY AS
9 MEMBERS OF THE TRAUMA ADVISORY COUNCIL; AND FOR OTHER
10 PURPOSES."

Subtitle

12 "TO INCLUDE MEMBERS OF THE ARKANSAS
13 GENERAL ASSEMBLY AS MEMBERS OF THE
14 TRAUMA ADVISORY COUNCIL."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18 SECTION 1. Arkansas Code Annotated § 20-13-807 is amended to read as
19 follows:

20 "20-13-807. Trauma Advisory Council.

21 (a) There is established an advisory council, to be known as the
22 Trauma Advisory Council, for the purpose of making recommendations,
23 advising, and providing assistance to the Division of Emergency Medical
24 Services of the Department of Health concerning the development of a
25 statewide trauma system.

26 (b) The advisory council shall consist of twelve (12) members who have
27 a demonstrated interest in trauma systems, to be appointed by the Governor as
28 follows:

29 (1) One (1) member appointed from a list of two (2) nominees
30 submitted by the Arkansas Chapter of the American College of Emergency
31 Physicians;

32 (2) One (1) member appointed from a list of two (2) nominees
33 submitted by the Arkansas Academy of Family Physicians;

1 (3) One (1) member appointed from a list of two (2) nominees
2 submitted by the Arkansas Chapter of the American College of Surgeons;

3 (4) One (1) member appointed from a list of two (2) nominees
4 submitted by the Arkansas Medical Society;

5 (5) One (1) member appointed from a list of two (2) nominees
6 submitted by the Arkansas Hospital Association;

7 (6) One (1) member appointed from a list of two (2) nominees
8 submitted by the Governor's Emergency Medical Services Advisory Council;

9 (7) One (1) member appointed from a list of two (2) nominees
10 submitted by the Arkansas Emergency Nurses' Association;

11 (8) One (1) member appointed from a list of two (2) nominees
12 submitted by the Arkansas Emergency Technicians' Association;

13 (9) One (1) member appointed from a list of two (2) nominees
14 submitted by the Arkansas Ambulance Association;

15 (10) One (1) member appointed from a list of two (2) nominees
16 submitted by the Arkansas Emergency Medical Services for Children Program;

17 (11) One (1) member appointed from a list of two (2) nominees
18 submitted by the Arkansas Trauma Society; and

19 (12) One (1) member appointed from the public at large as a
20 consumer representative who has an interest in trauma systems.

21 (c) The following shall also be members of the Trauma Advisory
22 Council:

23 (1) The Director of the Department of Human Services;

24 (2) The Director of the Highway Safety Program of the Arkansas State
25 Highway and Transportation Department;

26 (3) The Director of the Department of Arkansas State Police;

27 (4) Two (2) senators appointed by the President Pro Tem of the
28 Senate; and

29 (5) Four (4) representatives appointed by the Speaker of the
30 House of Representatives."

31

32 SECTION 2. All provisions of this act of a general and permanent
33 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
34 Code Revision Commission shall incorporate the same in the Code.

35

1 SECTION 3. If any provision of this act or the application thereof to
2 any person or circumstance is held invalid, such invalidity shall not affect
3 other provisions or applications of the act which can be given effect without
4 the invalid provision or application, and to this end the provisions of this
5 act are declared to be severable.

7 SECTION 4. All laws and parts of laws in conflict with this act are
8 hereby repealed.
