7 For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 26-60-110 RELATING TO
9 STATING THE AMOUNT OF FULL CONSIDERATION FOR A REAL ESTATE
10 TRANSACTION; AND FOR OTHER PURPOSES."

12 Subtitle

13 "AN ACT RELATING TO STATING THE AMOUNT
14 OF FULL CONSIDERATION FOR A REAL ESTATE
15 TRANSACTION."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. Arkansas Code 26-60-110(b) is amended to read as follows:

20 "(b) The county recorder of deeds shall not record any instrument
21 evidencing a transfer of title subject to this chapter unless:

22 (1) The instrument shall, at the time it is presented for
23 recording, have attached thereto or is accompanied by an affidavit in the
24 form provided in this chapter, containing the information required in this
25 chapter and have documentary stamps attached to the face of the instrument
26 evidencing full payment of the real property transfer tax on the transaction.
27 The instrument shall contain a notation on its face, which shall be recorded
28 as part of the instrument, that the affidavit was completed; or

29 (2)(A) In the alternative the instrument has stamped thereon or
30 attached thereto in a manner which will cause it to be recorded as a part of
31 the instrument the following statement:

32 I certify under penalty of false swearing that the legally correct
33 amount of documentary stamps have been placed on this instrument.

34 (B) This statement shall be signed by the grantee or his
35 agent, and the grantee's address shall be clearly shown on the instrument."

3 SECTION 2. *Arkansas Code 26-60-110 is amended by inserting an
4 additional subsection at the end thereof to read as follows:*

5 "(c) *The county recorder of deeds shall not record any instrument
6 whereon documentary stamps are attached in such manner that the amount
7 printed on each stamp is not visible.*"

8

9 SECTION 3. All provisions of this act of a general and permanent
10 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
11 Code Revision Commission shall incorporate the same in the Code.

12

13 SECTION 4. If any provision of this act or the application thereof to
14 any person or circumstance is held invalid, such invalidity shall not affect
15 other provisions or applications of the act which can be given effect without
16 the invalid provision or application, and to this end the provisions of this
17 act are declared to be severable.

18

19 SECTION 5. All laws and parts of laws in conflict with this act are
20 hereby repealed.
