10 PURPOSES."

14 HOSPITAL BOARD TO LEASE REAL PROPERTY"

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. Arkansas Code § 20-46-206 is amended to read as follows:
20 "20-46-206. Lease of certain lands.

21 (a) The State Hospital Board is authorized to enter into an agreement
22 or agreements with the War Memorial Stadium Commission, the Board of Trustees
23 of the University of Arkansas System, the Board of Visitors of the University
24 of Arkansas at Little Rock, or to the Arkansas Travelers Baseball Club, Inc.
25 to lease to the commission, to the board of trustees, to the board of
26 visitors, or to the baseball club those lands belonging to or under the
27 supervision of the State Hospital Board which are located in close proximity
28 to the War Memorial Stadium, Ray Winder Field or within the City Fair Park.
29 The agreement or agreements may provide for the leasing of lands for such
30 period of time and under such other terms as may be agreed upon by the
31 parties.

32 (b) All funds received by the State Hospital Board under agreements
33 for the lease of State Hospital lands as authorized in this section shall be
34 deposited in the State Treasury and credited to the fund out of which the
35 State Hospital is supported."

2 SECTION 2. All provisions of this act of general and permanent nature
3 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
4 Revision Commission shall incorporate the same in the Code.

5

6 SECTION 3. If any provisions of this act or the application thereof to
7 any person or circumstance is held invalid, the invalidity shall not affect
8 other provisions or applications of the act which can be given effect without
9 the invalid provisions or application, and to this end the provisions of this
10 act are declared to be severable.

11

12 SECTION 4. All laws and parts of laws in conflict with this act are
13 hereby repealed.
