## For An Act To Be Entitled

8 "AN ACT TO AUTHORIZE THE DEPARTMENT OF FINANCE AND  
9 ADMINISTRATION TO CREATE AND ISSUE ADDITIONAL TYPES OF  
10 SPECIAL LICENSE PLATES OR LICENSE PLATE DECALS; AND FOR  
11 OTHER PURPOSE."

## Subtitle

15 "AN ACT TO AUTHORIZE THE DEPARTMENT OF  
16 FINANCE AND ADMINISTRATION TO CREATE AND  
17 ISSUE ADDITIONAL TYPES OF SPECIAL  
18 LICENSE PLATES OR LICENSE PLATE DECALS."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22

23 *SECTION 1. (a) Any private, non-profit civic or educational*  
24 *organization having members residing in five (5) or more counties in this*  
25 *state, and which accepts members without regard to age, race, sex, religion,*  
26 *or national origin, may apply to the Department of Finance and Administration*  
27 *for the creation and issuance of a special license plate for use on passenger*  
28 *vehicles and class one (1) trucks. However, the department shall not issue a*  
29 *new special license plate under this section unless the department receives*  
30 *from the organization's members a minimum of five hundred (500) applications*  
31 *for issuance of such special license plate.*

32 *(b) The fee for issuance and renewal of a special license plate issued*  
33 *under this section shall be the same as is charged for a regular license*  
34 *plate issued for the motor vehicle as prescribed by law, plus a ten dollar*  
35 *(\$10.00) annual special license plate use fee which shall be deposited into*

1 *the State Central Services Funds as direct revenue for the support of the*  
2 *Department of Finance and Administration.*

3 *(c) The Director of the Department of Finance and Administration shall*  
4 *promulgate such rules and regulations as are necessary for the effective*  
5 *administration of this section. Such rules and regulations shall include*  
6 *criteria for the design and numbering of special license plates issued under*  
7 *this section.*

8  
9 SECTION 2. All provisions of this act of a general and permanent  
10 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
11 Code Revision Commission shall incorporate the same in the Code.

12  
13 SECTION 3. If any provision of this act or the application thereof to  
14 any person or circumstance is held invalid, such invalidity shall not affect  
15 other provisions or applications of the act which can be given effect without  
16 the invalid provision or application, and to this end the provisions of this  
17 act are declared to be severable.

18  
19 SECTION 4. All laws and parts of laws in conflict with this act are  
20 hereby repealed.
