HOUSE BILL 2127

For An Act To Be Entitled

"AN ACT TO PROVIDE FOR THE LICENSING OF MOBILE MANICURIST
UNITS; AND FOR OTHER PURPOSES."

Subtitle

"AN ACT TO PROVIDE FOR THE LICENSING OF
MOBILE MANICURIST UNITS."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. For purposes of this act:

(1) "Board" means the State Board of Cosmetology.

(2) "Mobile manicurist unit" means any self contained, self
supporting, enclosed mobile unit which is at least twenty-four feet (24_) in
length and which is licensed by the Board of Cosmetology as an establishment
for the practice of manicuring.

SECTION 2. The State Board of Cosmetology may license any mobile
manicurist unit which is equipped with the following functioning systems:

(1) a self-contained potable water tank of a capacity of no less than
one hundred (100) gallons and holding tanks of a capacity specified by the
board;

(2) continuous on-demand hot water tank with a capacity of not less
than six (6) gallons;

(3) a self-contained, recirculating, flush chemical toilet with
holding tank of a capacity specified by the board;

(4) a covered galvanized, stainless steel or other non-corrosive metal
container for the disposal of nail clippings and other waste materials;

(5) a split lead generator with a remote starter, muffler, and a vent

1 to the outside; and

2 (6) a sealed combustible heater with an outside vent.

4 SECTION 2. When issuing a license for a mobile manicurist unit the
5 board may prescribe the geographical boundaries within which it may be
6 operated. A mobile manicurist license may only be issued to a person
7 licensed by the State Board of Cosmetology to practice manicuring. The board
8 may levy an initial license issuance fee and annual renewal fees in such
9 amount which will defray the cost of administering this act.

11 SECTION 3. All monies collected under this act shall be deposited as
12 special revenues into the State Treasury to the credit of the Board of
13 Cosmetology Fund.

15 SECTION 4. The State Board of Cosmetology shall promulgate regulations
16 necessary to implement this act and any violations of this act or those
17 regulations shall be grounds for suspension or revocation of license issued
18 under this act.

20 SECTION 5. All provisions of this act of a general and permanent
21 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
22 Code Revision Commission shall incorporate the same in the Code.

24 SECTION 6. If any provision of this act or the application thereof to
25 any person or circumstance is held invalid, such invalidity shall not affect
26 other provisions or applications of the act which can be given effect without
27 the invalid provision or application, and to this end the provisions of this
28 act are declared to be severable.

29

30 SECTION 7. All laws and parts of laws in conflict with this act are
31 hereby repealed.
