19 Assembly from 1975 until 1994, a span of nineteen (19) years; and

25 WHEREAS, from 1991 through 1994, Jim Holland served as Vice-Chairman of

27 demonstrated a sense of fairness and diplomacy that will be remembered by all

30 WHEREAS, he was a knowledgeable, courteous and a tenacious member of
31 the Committee, who was a diligent advocate for his constituency in District
32 84 as well as the State of Arkansas; and

34 WHEREAS, Jim Holland worked tirelessly to ensure Highway 67 remained a
35 viable economic link for our State as a whole as well as the residents and
