## HOUSE RESOLUTION

8 COMMENDING THE ARKANSAS SCHOOL FOOD SERVICE ASSOCIATION  
9 FOR PROMOTING NUTRITION EDUCATION AND GOALS AND  
10 ENCOURAGING THE ARKANSAS DEPARTMENT OF EDUCATION TO ADOPT  
11 POLICY SUPPORTING IMPLEMENTATION OF THESE GOALS IN PUBLIC  
12 SCHOOLS.

### Subtitle

15 COMMENDING THE ARKANSAS SCHOOL FOOD SERVICE ASSOCIATION  
16 AND ENCOURAGING THE ADOPTION OF ITS NUTRITION GOALS FOR  
17 PUBLIC SCHOOLS.

19 WHEREAS, nutrition is critical to a child's growth and development; and  
20

21 WHEREAS, nutrition affects a child's readiness and ability to learn;  
22 and

24 WHEREAS, the National Action Plan to Improve the American Diet has  
25 recognized that early intervention is critical to a child's development and  
26 to long-term health and has identified schools, school-related groups and  
27 nutrition services in schools as a primary vehicle for meeting their goals;  
28 and

30 WHEREAS, since 1990, a National Education Goal has been that all  
31 children in America will start school ready to learn; and  
32

33 WHEREAS, readiness to learn is also one (1) of the Arkansas Education  
34 Goals; and

1        WHEREAS, children learn to make wise food choices based on both  
2 knowledge and experience; and

4        WHEREAS, nutrition education in schools is most effective when  
5 delivered in the context of a quality integrated school health program in  
6 which school meal programs provide that opportunity for students to practice  
7 what they learn in the classroom; and

9        WHEREAS, a total school environment that supports wise eating choices  
10 is important to the success of school nutrition programs; and

11

12        WHEREAS, many national organizations including the American Academy of  
13 Pediatrics, the National PTA, the American Dietetic Association, the National  
14 School Boards Association and the Association of School Business Officials  
15 International have endorsed eleven (11) core concepts adopted by the American  
16 School Food Service Association as necessary components of school policy that  
17 will ensure nutrition integrity of school meals,

20 NOW THEREFORE,

21 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTIETH GENERAL  
22 ASSEMBLY OF THE STATE OF ARKANSAS:

24        THAT the House of Representatives of the State of Arkansas commends the  
25 Arkansas School Food Service Association for its promotion of these important  
26 policy goals and encourages the Arkansas Department of Education and all  
27 school districts to adopt policy supporting their implementation in all  
28 schools.
