1 for a period of time to exceed nine (9) months in any single fiscal year. 2 Provided, however, that no employee of the Commemorative Commission of the 3 Department of Arkansas Heritage who is employed as "Extra Help" may receive 4 an amount to exceed seventy-five percent (75%) of the maximum annual salary 5 for a comparable position as authorized by Arkansas Code 21-5-201 et seq. 6 during any fiscal year, nor shall such employee be employed for a period of 7 time to exceed fifteen hundred (1500) hours in any single fiscal year. g TRANSFER OF STATE FUNDS - HISTORIC PRESERVATION PROGRAM. 9 10 Subject to such rules and regulations as may be implemented by the Chief 11 Fiscal Officer of the State and after seeking prior review by the Arkansas 12 Legislative Council, the Historic Preservation Officer is hereby authorized 13 to transfer funds and appropriations for Regular Salaries; Personal Services 14 Matching (Social Security, Retirement, Workmen's Compensation and 15 Unemployment Insurance); Maintenance and Operations; Grants; Conference Fees 16 and Travel; Professional Services; and Extra Help; under the various sections 17 in this Act which appropriate State Funds, whenever it appears by projecting 18 the expenditures of any of these appropriations that there will be a need of 19 funds or appropriations in one item and that there is an excess of funds or 20 appropriations in another item. The transfer of appropriations and funds 21 shall be effected only upon approval of the Chief Fiscal Officer of the 22 State, who will then authorize the State Treasurer and State Auditor to 23 adjust the affected accounts on their books of record respectively. 2.4 25 SECTION 63. NATURAL AND CULTURAL RESOURCES COUNCIL. The Director of 26 the Department of Arkansas Heritage shall be the disbursing officer for the appropriations provided by Sections 59 and 60 of this Act. Further, if grants are made to state agencies from the appropriations provided by 29 Sections 59 and 60 herein, the corresponding amount of appropriation and 30 funding of such grant may be transferred to such state agency for use in 31 classifications of expenditures as determined by conditions of the grant and 32 the state agency. 33 In the event that such grants make it necessary to employ additional 34

35 personnel, the Department of Arkansas Heritage upon seeking prior review of

         SECTION 69. GENERAL REPEALER. All laws and parts of laws in conflict

         SECTION 70. EMERGENCY CLAUSE. It is hereby found and determined by

13 the Eightieth General Assembly, that the Constitution of the State of
14 Arkansas prohibits the appropriation of funds for more than a two (2) year
15 period; that the effectiveness of this Act on July 1, 1995 is essential to
16 the operation of the agency for which the appropriations in this Act are
17 provided, and that in the event of an extension of the Regular Session, the
18 delay in the effective date of this Act beyond July 1, 1995 could work
19 irreparable harm upon the proper administration and provision of essential
20 governmental programs. Therefore, an emergency is hereby declared to exist
21 and this Act being necessary for the immediate preservation of the public
22 peace, health and safety shall be in full force and effect from and after
23 July 1, 1995.
