For An Act To Be Entitled

7 "AN ACT TO AMEND ARK. CODE §§ 19-1-504 and 6-20-222 TO
8 AUTHORIZE LOCAL SCHOOL DISTRICTS TO INVEST DISTRICT FUNDS
9 IN BONDS, NOTES, DEBENTURES, OR OTHER OBLIGATIONS ISSUED
10 BY AN AGENCY OF THE U.S. GOVERNMENT; AND FOR OTHER
11 PURPOSES."

14 "TO AUTHORIZE SCHOOL DISTRICTS TO INVEST
15 DISTRICT FUNDS IN BONDS, NOTES,
16 DEBENTURES OR OTHER OBLIGATIONS ISSUED
17 BY AN AGENCY OF THE U.S. GOVERNMENT."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. Arkansas Code Annotated § 19-1-504(b) is hereby amended to
22 read as follows:

23 "(b) Funds of school districts shall be invested by school district
24 treasurers in cases where school districts have treasurers or by county
25 treasurers in cases where school districts do not have treasurers. These
26 investments shall be in general obligation bonds of the United States of
27 America, in bonds, notes, debentures, or other obligations issued by an
28 agency of the United States Government, in general obligation bonds of the
29 State of Arkansas, or in bank certificates of deposit, as and to the extent
30 directed by the boards of directors of the school districts."

31

32 SECTION 2. Arkansas Code Annotated § 6-20-222(a) is hereby amended to
33 read as follows:

34 "(a) All general deposits of school funds in banks shall be secured by

1 general obligation bonds of the United States, bonds, notes, debentures, or
2 other obligations issued by an agency of the United States Government, bonds
3 of the State of Arkansas, or by bonds of a political subdivision thereof
4 which has never defaulted on any of its obligations, in an amount at least
5 equal to the amount of such deposit, or by a bond executed by a surety
6 company authorized to do business in the State of Arkansas, the surety on
7 such bond to be approved by the Director of General Education."

8

9 SECTION 3. All provisions of this act of a general and permanent
10 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
11 Code Revision Commission shall incorporate the same in the Code.

12

13 SECTION 4. If any provision of this act or the application thereof to
14 any person or circumstance is held invalid, such invalidity shall not affect
15 other provisions or applications of the act which can be given effect without
16 the invalid provision or application, and to this end the provisions of this
17 act are declared to be severable.

18

19 SECTION 5. All laws and parts of laws in conflict with this act are
20 hereby repealed.
