SENATE BILL 19

For An Act To Be Entitled

8 "AN ACT TO AMEND SUBCHAPTERS 4 AND 8 OF CHAPTER 15 OF
9 TITLE 27 OF THE ARKANSAS CODE TO AUTHORIZE THE SURVIVING
10 SPOUSE OF DECEASED RECIPIENTS OF THE CONGRESSIONAL MEDAL
11 OF HONOR, AND DECEASED DISABLED AMERICAN VETERANS TO
12 OBTAIN THE SPECIAL LICENSE PLATES PROVIDED FOR THEIR
13 SPOUSE; AND FOR OTHER PURPOSES."

Subtitle

16 "SURVIVING SPOUSES OF DECEASED DISABLED
17 AMERICAN VETERANS AND DECEASED
18 RECIPIENTS OF CONGRESSIONAL MEDAL OF
19 HONOR ARE AUTHORIZED TO RECEIVE SPECIAL
20 LICENSE PLATES."

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Subchapter 4 of Chapter 15 of Title 27 of the Arkansas Code
25 is amended by inserting an additional section at the end thereof to read as
26 follows:

27 "27-15-407. The surviving spouse of a deceased disabled veteran as
28 defined in this subchapter shall, upon payment of the normal registration fee
29 for the motor vehicle involved, be issued the special disabled American
30 veteran license plate provided for in this subchapter. *The surviving spouse*
31 *shall not be eligible for parking privileges in designated accessible parking*
32 *spaces for persons with disabilities unless the surviving spouse is a person*
33 *with a disability as defined in Arkansas Code 27-15-302."*

35 SECTION 2. Subchapter 8 of Chapter 15 of Title 27 of the Arkansas Code

1 is amended by inserting an additional section at the end thereof to read as
2 follows:

3 "27-15-807. The surviving spouse of a deceased recipient of the
4 Congressional Medal of Honor shall be entitled to the special license plates
5 provided for in this subchapter and such plates shall be issued without
6 charge to the surviving spouse."

7

8 SECTION 3. All provisions of this act of a general and permanent
9 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
10 Code Revision Commission shall incorporate the same in the Code.

11

12 SECTION 4. If any provision of this act or the application thereof to
13 any person or circumstance is held invalid, such invalidity shall not affect
14 other provisions or applications of the act which can be given effect without
15 the invalid provision or application, and to this end the provisions of this
16 act are declared to be severable.

17

18 SECTION 5. All laws and parts of laws in conflict with this act are
19 hereby repealed.
