SENATE BILL 271

For An Act To Be Entitled

"AN ACT AMENDING TITLE 19, CHAPTER 11, SUBCHAPTER 2 OF THE
ARKANSAS CODE ANNOTATED TO AUTHORIZE USE OF A MULTIPLE
AWARD CONTRACTS PROCEDURE BY THE OFFICE OF STATE
PURCHASING; AND FOR OTHER PURPOSES."

Subtitle

"TO AMEND THE ARKANSAS CODE TO AUTHORIZE
USE OF A MULTIPLE AWARD CONTRACTS
PROCEDURE BY THE OFFICE OF STATE
PURCHASING."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. Arkansas Code Annotated § 19-11-204 is hereby amended to
read as follows:

"§ 19-11-204. Definitions concerning source selection and contract
formation.

As used in this subchapter, unless the context otherwise requires:

- (1) "Competitive sealed bidding": See § 19-11-229(a);
- (2) "Competitive sealed proposals": See § 19-11-230(a);
- (3) "Established catalogue price" means the price included in a

catalogue, price list, schedule, or other form that:

- (A) Is regularly maintained by a manufacturer or contractor;
- (B) Is either published or otherwise available for inspection by
customers; and

(C) States prices at which sales are currently or were last made
to a significant number of buyers constituting the general buying public for

1 the commodities or services involved;

2 (4) "Invitation for bids" means all documents, whether attached or
3 incorporated by reference, utilized for soliciting bids in accordance with
4 the procedures set forth in § 19-11-229, which refers to competitive sealed
5 bidding;

6 (5) "Purchase description" means specifications or any other document
7 describing the commodities or services to be procured;

8 (6) "Request for proposals" means all documents, whether attached or
9 incorporated by reference, utilized for soliciting proposals in accordance
10 with the procedures set forth in § 19-11-230, which refers to competitive
11 sealed proposals, § 19-11-231, which refers to small purchases, § 19-11-232,
12 which refers to proprietary or sole source procurements, § 19-11-233, which
13 refers to emergency procurements, or § 19-11-234, which refers to competitive
14 bidding;

15 (7) "Responsible bidder or offeror" means a person who has the
16 capability in all respects to perform fully the contract requirements, and
17 the integrity and reliability which will assure good faith performance;

18 (8) "Responsive bidder" means a person who has submitted a bid under §
19 19-11-229, which refers to competitive sealed bidding, which conforms in all
20 material respects to the invitation for bids, including the specifications
21 set forth in the invitation;

22 (9) "Emergency procurement" means the acquisition of commodities or
23 services which, if not immediately initiated, will endanger human life or
24 health, state property, or the functional capability of a state agency;

25 (10) "Small purchases" means any procurement not exceeding a purchase
26 price of *one thousand dollars (\$1,000)*. Small purchases may be procured
27 without seeking competitive bids or competitive sealed bids; however,
28 competition should be used to the maximum extent practicable. Items under
29 state contract are excluded;

30 (11) "Competitive bidding": See § 19-11-234(a); and

31 (12) "Multiple award contracts" means a method of procurement whereby
32 an indefinite quantity contract is awarded to more than one supplier for
33 furnishing a like item or category of items."

35 SECTION 2. Arkansas Code Annotated § 19-11-228 is hereby amended to

1 read as follows:

2 "§ 19-11-228. Methods of source selection.

3 Unless otherwise authorized by law, all contracts shall be awarded by
4 competitive sealed bidding, pursuant to § 19-11-229, which refers to
5 competitive sealed bidding, except as provided in:

6 (1) Section 19-11-230, which refers to competitive sealed proposals;

7 (2) Section 19-11-231, which refers to small purchases;

8 (3) Section 19-11-232, which refers to proprietary or sole source
9 procurements;

10 (4) Section 19-11-233, which refers to emergency procurements;

11 (5) Section 19-11-234, which refers to competitive bidding; or

12 (6) Section 19-11-262, which refers to multiple award contracts."

13

14 SECTION 3. Title 19, Chapter 11, Subchapter 2 of the Arkansas Code
15 Annotated is hereby amended by adding a new section to read as follows:

16 "19-11-262. Multiple award contracts.

17 (a) Multiple award contracts may be made only if the State Purchasing
18 Director determines in writing that a single award is not advantageous to the
19 State of Arkansas. *The determination, in writing, shall state a rationale and*
20 *basis for the multiple award contract.* Multiple award contracts shall be
21 limited to the least number of suppliers necessary to meet the requirements
22 of the using agencies."

23 (b) If the State Purchasing Director anticipates that multiple award
24 contracts will be made, the invitation for bids shall include a notification
25 of the right of the Office of State Purchasing to make such an award and the
26 criteria upon which such an award will be based."

27

28 SECTION 4. All provisions of this act of a general and permanent
29 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
30 Code Revision Commission shall incorporate the same in the Code.

31

32 SECTION 5. If any provision of this act or the application thereof to
33 any person or circumstance is held invalid, such invalidity shall not affect
34 other provisions or applications of the act which can be given effect without
35 the invalid provision or application, and to this end the provisions of this

1 act are declared to be severable.

2

3 SECTION 6. All laws and parts of laws in conflict with this act are
4 hereby repealed.
