## 7 For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE § 26-52-510 AND § 26-53-126  
9 TO PROVIDE THAT LICENSED MOTOR VEHICLE DEALERS AND USED  
10 MOTOR VEHICLE DEALERS WHO PURCHASE USED MOTOR VEHICLES MAY  
11 OBTAIN TITLE TO THE USED MOTOR VEHICLES WITHOUT SALES OR  
12 USE TAX BEING COLLECTED ON THE TRANSFER; TO ALLOW  
13 MANUFACTURED HOME DEALERS WHO PURCHASE USED MANUFACTURED  
14 HOMES TO OBTAIN TITLE TO THE USED MANUFACTURED HOMES  
15 WITHOUT SALES OR USE TAX BEING COLLECTED ON THE TRANSFER;  
16 AND FOR OTHER PURPOSES."

## 18 Subtitle

19 "AN ACT TO PROVIDE THAT USED MOTOR  
20 VEHICLES PURCHASED BY MOTOR VEHICLE  
21 DEALERS AND USED MOTOR VEHICLE DEALERS  
22 MAY OBTAIN TITLE TO THE USED MOTOR  
23 VEHICLES WITHOUT SALES OR USE TAX BEING  
24 COLLECTED."

27 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

28

29 SECTION 1. Arkansas Code § 26-52-510 is amended by adding a new  
30 subsection (f) to read as follows:

31 "(f) Any motor vehicle dealer licensed pursuant to § 27-14-601(a)(6)  
32 who has purchased a used motor vehicle may, upon payment of all applicable  
33 registration and title fees, register the vehicle for the sole purpose of  
34 obtaining a certificate of title to the vehicle without payment of gross  
35 receipts tax. No license plate shall be provided with such registration and

1 the used vehicle titled by a dealer under this subsection may not be operated  
2 on the public highways unless there is displayed thereon a dealer's license  
3 plate issued under the provisions of § 27-14-601(a)(6)(B)(ii)."

5       SECTION 2. Arkansas Code § 26-52-504 is amended by adding a new  
6 subsection (d) to read as follows:

7           "(d) Any manufactured home dealer licensed pursuant to § 27-14-  
8 601(a)(6) who has purchased a used manufactured home may, upon payment of all  
9 applicable registration and title fees, register the used manufactured home  
10 for the sole purpose of obtaining a certificate of title without payment of  
11 gross receipts taxes. No license plate or decal shall be provided with such  
12 registration, and any used manufactured home titled by a dealer under this  
13 subsection may not be transported on the public highways unless there is  
14 displayed thereon a dealer's license plate issued under the provisions of §  
15 27-14-601(a)(6)(B)(ii)."

17       SECTION 3. Arkansas Code § 26-53-126 is amended by adding a new  
18 subsection (e) to read as follows:

19           "(e) Any motor vehicle dealer licensed pursuant to § 27-14-601(a)(6)  
20 who has purchased a used motor vehicle may, upon payment of all applicable  
21 registration and title fees, register the vehicle for the sole purpose of  
22 obtaining a certificate of title to the vehicle without payment of use tax.  
23 No license plate shall be provided with such registration and the used  
24 vehicle titled by a dealer under this subsection may not be operated on the  
25 public highways unless there is displayed thereon a dealer's license plate  
26 issued under the provisions of § 27-14-601(a)(6)(B)(ii)."

28       SECTION 4. All provisions of this act of a general and permanent  
29 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
30 Code Revision Commission shall incorporate the same in the Code.

31

32       SECTION 5. If any provision of this act or the application thereof to  
33 any person or circumstance is held invalid, such invalidity shall not affect  
34 other provisions or applications of the act which can be given effect without  
35 the invalid provision or application, and to this end the provisions of this

1 act are declared to be severable.

3 SECTION 6. All laws and parts of laws in conflict with this act are  
4 hereby repealed.
