SENATE BILL 332

For An Act To Be Entitled

8 "AN ACT TO AMEND ARK. CODE ANN. §14-171-201, et seq. (THE
9 CITY-COUNTY TOURIST MEETING AND ENTERTAINMENT FACILITIES
10 ASSISTANCE LAW) TO INCLUDE THE STATE FAIRGROUNDS AND WAR
11 MEMORIAL STADIUM AS ELIGIBLE FACILITIES; AND FOR OTHER
12 PURPOSES."

Subtitle

16 "AMENDS ARK. CODE ANN. §14-171-201, ET
17 SEQ. TO INCLUDE STATE FAIRGROUNDS AND
18 WAR MEMORIAL STADIUM AS ELIGIBLE
19 FACILITIES."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Ark. Code Ann. §14-171-203(3) is amended to read as
24 follows: "(3) City means any city of the first or second class in
25 this state and also means the War Memorial Stadium Commission, the Arkansas
26 Livestock and Poultry Commission, and the Arkansas State Fair and Livestock
27 Show Association;"

29 SECTION 2. Ark. Code Ann. §14-171-203(7) is amended to read as
30 follows:

31 "(7) Eligible facilities means any publicly owned tourist meeting
32 facilities or tourist entertainment facilities acquired or completed, or
33 substantially reconstructed or expanded, after December 31, 1974 and also
34 means War Memorial Stadium, and the facilities on the Arkansas State
35 Fairgrounds in Little Rock, Arkansas. Manufacturing facilities are

1 specifically excluded from this definition;"

3 SECTION 3. Nothing in Ark. Code Ann. §22-3-1009 shall prohibit the use
4 of funds provided under Ark. Code Ann. §14-171-201, et seq. (The City-County
5 Tourist Meeting and Entertainment Facilities Assistance Law) for eligible
6 facilities as defined in this act.

7

8 SECTION 4. All provisions of this act of a general and permanent
9 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
10 Code Revision Commission shall incorporate the same in the Code.

11

12 SECTION 5. If any provision of this act or the application thereof to
13 any person or circumstance is held invalid, such invalidity shall not affect
14 other provisions or applications of the act which can be given effect without
15 the invalid provision or application, and to this end the provisions of this
16 act are declared to be severable.

17

18 SECTION 6. All laws and parts of laws in conflict with this act are
19 hereby repealed.
