## For An Act To Be Entitled

7 "AN ACT TO REQUIRE EACH LICENSED AUCTIONEER TO COMPLETE  
8 SIX HOURS OF CONTINUING EDUCATION ANNUALLY AS A CONDITION  
9 OF RENEWAL OF HIS OR HER AUCTIONEER LICENSE; TO PROVIDE  
10 THAT THE CONTINUING EDUCATION PROGRAMS SHALL BE APPROVED  
11 BY THE ARKANSAS AUCTIONEER\_S LICENSING BOARD AND  
12 ADMINISTERED BY THE ARKANSAS AUCTIONEER\_S ASSOCIATION; AND  
13 FOR OTHER PURPOSES."

### Subtitle

16 "TO REQUIRE LICENSED AUCTIONEERS TO  
17 COMPLETE SIX HOURS OF CONTINUING  
18 EDUCATION ANNUALLY."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22

23 SECTION 1. Every application to the Arkansas Auctioneer\_s Licensing  
24 Board for annual renewal of the license of an auctioneer shall be accompanied  
25 by proof that the applicant has satisfactorily completed six (6) hours of  
26 continuing education in approved programs within the preceding twelve month  
27 period. No auctioneer\_s license shall be renewed unless the application for  
28 renewal is accompanied by the proof required herein.

29

30 SECTION 2. All programs of continuing education for licensed  
31 auctioneers shall be subject to approval of the Arkansas Auctioneer\_s  
32 Licensing Board. The board is authorized to prescribe by regulations the  
33 minimum standards and requirements for continuing education programs for  
34 auctioneers, the procedures and policies for administering such programs, and  
35 the manner and conditions under which credit will be granted for

1 participation in such programs.

2

3 SECTION 3. The Arkansas Auctioneer\_s Association shall administer and  
4 conduct such auctioneer continuing education programs as shall be approved by  
5 the Arkansas Auctioneer\_s Licensing Board.

6

7 SECTION 4. All provisions of this act of a general and permanent  
8 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
9 Code Revision Commission shall incorporate the same in the Code.

10

11 SECTION 5. If any provision of this act or the application thereof to  
12 any person or circumstance is held invalid, such invalidity shall not affect  
13 other provisions or applications of the act which can be given effect without  
14 the invalid provision or application, and to this end the provisions of this  
15 act are declared to be severable.

16

17 SECTION 6. All laws and parts of laws in conflict with this act are  
18 hereby repealed.
