## For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND  
9 OPERATING EXPENSES FOR THE POST PRISON TRANSFER BOARD WHICH  
10 SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS  
11 APPROPRIATED BY ACT 958 OF 1993, FOR THE REMAINDER OF THE  
12 BIENNIAL PERIOD ENDING JUNE 30, 1995; AND FOR OTHER  
13 PURPOSES."

## Subtitle

16 "AN ACT FOR THE POST PRISON TRANSFER  
17 BOARD SUPPLEMENTAL APPROPRIATION."  
18

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. REGULAR SALARIES. There is hereby established for the Post  
22 Prison Transfer Board, the following maximum number of regular employees which  
23 shall be supplemental and in addition to those positions authorized in Section  
24 1 of Act 958 of 1993 and whose salaries shall be governed by the provisions of  
25 the Uniform Classification and Compensation Act (Arkansas Code §§21-5-201 et  
26 seq.), or its successor, and all laws amendatory thereto. Provided, however,  
27 that any position to which a specific maximum annual salary is set out herein  
28 in dollars, shall be exempt from the provisions of said Uniform Classification  
29 and Compensation Act. All persons occupying positions authorized herein are  
30 hereby governed by the provisions of the Regular Salaries Procedures and  
31 Restrictions Act (Arkansas Code §21-5-101), or its successor.

6 SECTION 2. APPROPRIATIONS. There is hereby appropriated, to the Post  
 7 Prison Transfer Board, to be payable from the State General Services Fund  
 8 Account, for personal services and operating expenses of the Post Prison  
 9 Transfer Board which shall be supplemental and in addition to those funds  
 10 appropriated in Section 2 of Act 958 of 1993, for the remainder of the  
 11 ~~biennial period ending June 30, 1995, the following:~~

26 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 27 authorized by this Act shall be limited to the appropriation for such agency  
 28 and funds made available by law for the support of such appropriations; and  
 29 the restrictions of the State Purchasing Law, the General Accounting and  
 30 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 31 Procedures and Restrictions Act, or their successors, and other fiscal control  
 32 laws of this State, where applicable, and regulations promulgated by the  
 33 Department of Finance and Administration, as authorized by law, shall be  
 34 strictly complied with in disbursement of said funds.

1           SECTION 4.   LEGISLATIVE INTENT.   It is the intent of the General  
2 Assembly that any funds disbursed under the authority of the appropriations  
3 contained in this Act shall be in compliance with the stated reasons for which  
4 this Act was adopted, as evidenced by the Agency Requests, Executive  
5 Recommendations and Legislative Recommendations contained in the budget  
6 manuals prepared by the Department of Finance and Administration, letters, or  
7 summarized oral testimony in the official minutes of the Arkansas Legislative  
8 Council or Joint Budget Committee which relate to its passage and adoption.

10           SECTION 5.   CODE.   All provisions of this Act of a general and permanent  
11 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
12 Code Revision Commission shall incorporate the same in the Code.

14           SECTION 6.   SEVERABILITY.   If any provision of this Act or the  
15 application thereof to any person or circumstance is held invalid, such  
16 invalidity shall not affect other provisions or applications of the Act which  
17 can be given effect without the invalid provision or application, and to this  
18 end the provisions of this Act are declared to be severable.

20           SECTION 7.   GENERAL REPEALER.   All laws and parts of laws in conflict  
21 with this Act are hereby repealed.

22

23           SECTION 8.   EMERGENCY CLAUSE.   It is hereby found and determined by the  
24 Eightieth General Assembly that funds provided by the General Assembly for the  
25 operations of the Post Prison Transfer Board are, due to unforeseen  
26 circumstances, insufficient for the Post Prison Transfer Board to continue to  
27 provide essential governmental services; that the provisions of this act will  
28 provide the necessary monies for the Post Prison Transfer Board to continue  
29 such services; and that a delay in the effective date of this Act could work  
30 irreparable harm upon the proper administration and provision of essential  
31 governmental programs.   Therefore, an emergency is hereby declared to exist  
32 and this Act being necessary for the immediate preservation of the public  
33 peace, health and safety shall be in full force and effect from and after the  
34 date of its passage and approval.
