7 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED SEC. 15-5-1103(2)
8 TO PERMIT BONA FIDE DEVELOPMENT FINANCE CORPORATIONS TO
9 PARTICIPATE IN THE CAPITAL ACCESS PROGRAM ADMINISTERED BY
10 THE ARKANSAS DEVELOPMENT FINANCE AUTHORITY; AND FOR OTHER
11 PURPOSES."

14 "TO AMEND ARKANSAS CODE ANNOTATED SEC.
15 15-5-1103(2) TO PERMIT BONA FIDE
16 DEVELOPMENT FINANCE CORPORATIONS TO
17 PARTICIPATE IN THE CAPITAL ACCESS
18 PROGRAM ADMINISTERED BY THE ARKANSAS
19 DEVELOPMENT FINANCE AUTHORITY"

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22

23 SECTION 1. Arkansas Code Annotated Sec. 15-5-1103(2) is amended to
24 read as follows:

25 "(2) Financial institution means all state banks, savings and loan
26 associations, *corporations organized pursuant to either the Arkansas*
27 *Development Finance Corporation Act, Ark. Code Ann. Sec. 15-4-901, et. seq.,*
28 *as amended, or the County and Regional Industrial Development Corporation*
29 *Act, Ark. Code Ann. § 15-4-1201, et seq., as amended,* and any other financial
30 institutions of this state which are or shall become depositories of state
31 funds which agree to participate in the program;"

32

33 SECTION 2. All provisions of this act of a general and permanent
34 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas

¹ Code Revision Commission shall incorporate the same in the Code.

3 SECTION 3. If any provision of this act or the application thereof to
4 any person or circumstance is held invalid, such invalidity shall not affect
5 other provisions or applications of the act which can be given effect without
6 the invalid provision or application, and to this end the provisions of this
7 act are declared to be severable.

8

9 SECTION 4. All laws and parts of laws in conflict with this act are
10 hereby repealed.

11

12 SECTION 5. EMERGENCY. It is hereby found and determined by the
13 General Assembly that bona fide development finance corporations should be
14 but are not presently authorized to participate in the Capital Access Program
15 administered by the Arkansas Development Finance Authority, and that such
16 participation will promote the economic stability and development of the
17 State. Therefore, an emergency is hereby declared to exist and this act
18 being necessary for the immediate preservation of the public peace, health
19 and safety shall be in full force and effect from and after its passage and
20 approval.
