7 For An Act To Be Entitled

8 "AN ACT TO TRANSFER THE BENTON DETOXIFICATION SERVICES
9 CENTER OF THE BUREAU OF ALCOHOL AND DRUG ABUSE PREVENTION
10 OF THE DEPARTMENT OF HEALTH TO THE DIVISION OF MENTAL
11 HEALTH OF THE DEPARTMENT OF HUMAN SERVICES; AND FOR OTHER
12 PURPOSES."

14 Subtitle

15 "TO TRANSFER THE BENTON DETOXIFICATION
16 SERVICES CENTER OF THE BUREAU OF ALCOHOL
17 AND DRUG ABUSE PREVENTION OF THE
18 DEPARTMENT OF HEALTH TO THE DIVISION OF
19 MENTAL HEALTH OF THE DEPARTMENT OF HUMAN
20 SERVICES."

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23

24 SECTION 1. *The Benton Detoxification Services Center of the Bureau of
25 Alcohol and Drug Abuse Prevention of the Department of Health is transferred
26 by a Type 1 transfer as provided in A.C.A. 25-2-104 to the Division of Mental
27 Health of the Department of Human Services.*

28

29 SECTION 2. *Any and all other powers, duties, functions, records,
30 property and funds administered or provided by other support divisions within
31 the Department of Health for the Benton Detoxification Services Center shall
32 be transferred to the Department of Human Services, Division of Mental
33 Health.*

34

35 SECTION 3. All provisions of this act of general and permanent nature

1 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
2 Revision Commission shall incorporate the same in the Code.

3

4 SECTION 4. If any provisions of this act or the application thereof to
5 any person or circumstance is held invalid, the invalidity shall not affect
6 other provisions or applications of the act which can be given effect without
7 the invalid provisions or application, and to this end the provisions of this
8 act are declared to be severable.

9

10 SECTION 5. All laws and parts of laws in conflict with this act are
11 hereby repealed.
