# A Bill

SENATE BILL 433

## For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS 27-15-2702 TO CLARIFY THE LAW TO  
9 PROVIDE THAT THE ANNUAL RENEWAL OF SPECIAL FIRE FIGHTERS  
10 MOTOR VEHICLE LICENSE PLATES SHALL BE AT THE NORMAL FEE;  
11 AND FOR OTHER PURPOSES."

## Subtitle

14 "TO PROVIDE THAT THE ANNUAL RENEWAL OF  
15 SPECIAL FIRE FIGHTERS MOTOR VEHICLE  
16 LICENSE PLATES SHALL BE AT THE NORMAL  
17 FEE."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code 27-15-2702(a) is amended to read as follows:

22 "(a) Any person who is certified by the Fire Protection Services board  
23 as a certified fire fighter shall be entitled to a special fire fighter\_s  
24 motor vehicle license plate upon paying the normal fee plus ten dollars  
25 (\$10.00) for the initial issuance of the license plate. The cost of the  
26 annual renewal shall be the normal fee only."

28 SECTION 2. All provisions of this act of a general and permanent  
29 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
30 Code Revision Commission shall incorporate the same in the Code.

32 SECTION 3. If any provision of this act or the application thereof to  
33 any person or circumstance is held invalid, such invalidity shall not affect  
34 other provisions or applications of the act which can be given effect without  
35 the invalid provision or application, and to this end the provisions of this

1 act are declared to be severable.

3 SECTION 4. All laws and parts of laws in conflict with this act are  
4 hereby repealed.

5

6 SECTION 5. EMERGENCY. It is hereby found and determined by the  
7 General Assembly that confusion exists over the interpretation of the present  
8 law establishing the fee for special fire fighters motor vehicle license  
9 plates; that the intent of the law is that the fire fighters pay an  
10 additional ten dollars for the original issuance of the plate, and that  
11 annual renewals be at the normal rate; that this act makes such  
12 clarification; and this act should go into effect immediately in order to  
13 correct the interpretation of the present law as soon as possible.  
14 Therefore, an emergency is hereby declared to exist, and this act being  
15 immediately necessary for the preservation of the public peace, health, and  
16 safety shall be in full force and effect from and after its passage and  
17 approval.
