SENATE BILL 434

For An Act To Be Entitled

8 "AN ACT TO AUTHORIZE THE ARKANSAS JUDICIAL COUNCIL TO MAKE
9 RECOMMENDATIONS TO THE GENERAL ASSEMBLY REGARDING THE
10 ARKANSAS JUDICIAL RETIREMENT SYSTEM; AND FOR OTHER
11 PURPOSES."

14 "TO AUTHORIZE THE ARKANSAS JUDICIAL
15 COUNCIL TO MAKE RECOMMENDATIONS
16 REGARDING THE ARKANSAS JUDICIAL
17 RETIREMENT SYSTEM."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 *SECTION 1. The Arkansas Judicial Council is authorized to make*
22 *recommendations to the regular or special session of the General Assembly*
23 *regarding proposed changes to the Arkansas Judicial Retirement System. As*
24 *used in this act, the term "Judicial Council" or "Council" means the Arkansas*
25 *Judicial Council whose members are the trial and appellate judges of*
26 *Arkansas.*

28 *SECTION 2. All bills introduced in either house of the General*
29 *Assembly to change any law regarding the Arkansas Judicial Retirement System*
30 *shall be referred to the Joint Committee on Retirement and Social Security*
31 *Programs.*

33 *SECTION 3. The Joint Committee on Public Retirement and Social*
34 *Security Programs shall request a letter from the Arkansas Judicial Council*
35 *certifying that the Council has reviewed and made a recommendation on the*

1 *proposal. The letter shall be certified by the secretary-treasurer of the*
2 *Council.*

4 *SECTION 4. A bill to change any law regarding the Arkansas Judicial*
5 *Retirement System shall not be acted upon until the Council's letter is*
6 *received and attached to the bill. Upon suspension of the Rules of the*
7 *Committee, a bill may be withdrawn from the Joint Committee on Public*
8 *Retirement and Social Security Programs and acted upon without the Council's*
9 *letter attached thereto.*

11 *SECTION 5. All provisions of this act of a general and permanent*
12 *nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas*
13 *Code Revision Commission shall incorporate the same in the Code.*

14

15 *SECTION 6. If any provision of this act or the application thereof to*
16 *any person or circumstance is held invalid, such invalidity shall not affect*
17 *other provisions or applications of the act which can be given effect without*
18 *the invalid provision or application, and to this end the provisions of this*
19 *act are declared to be severable.*

20

21 *SECTION 7. All laws and parts of laws in conflict with this act are*
22 *hereby repealed.*
