         SECTION 1. Arkansas Code 7-1-101 is amended to read as follows:

         "7-1-101. Definitions.

         As used in this act, unless the context otherwise requires:
23
         (1)(A) Political party means any group of voters which, at the
25 last-preceding general election, polled for its candidate for Governor in the
26 state or nominees for presidential electors at least three percent (3%) of
27 the entire vote cast for the office; or which files with the Secretary of
28 State a petition signed by qualified electors equal in number to at least
29 three percent (3%) of the total vote cast for the Office of Governor or
30 nominees for presidential electors at the last-preceding election, declaring
31 their intention of organizing a political party, the name of which shall be
32 stated in the declaration, and of participating in the next-succeeding
33 general election.
               (B) Except in preferential presidential primary elections, the
34
```

35 petition shall be filed with the Secretary of State not later than 12:00 noon

- 1 of the first Tuesday in May before the preferential primary election for the
- 2 general election in which the political party filing the petition desires to
- 3 participate. No group of electors shall assume a name or designation which
- 4 is similar, in the opinion of the Secretary of State, to that of an existing
- 5 political party as to confuse or mislead the voters at an election.
- 6 (C) When any political party fails to obtain three percent (3%)
- 7 of the total votes cast at an election for the Office of Governor or nominees
- 8 for presidential electors, it shall cease to be a political party;
- 9 (2) Primary election means any election held by a political party in
- 10 the manner provided by law for the purpose of selecting nominees of said
- 11 political party for certification as candidates for election at any general
- 12 or special election in this state;
- 13 (3) General or special election means the regular biennial or annual
- 14 elections for election of United States, state, district, county, township,
- 15 and municipal officials and the special elections to fill vacancies therein
- 16 and special elections to approve any measure. The term, as used in this act,
- 17 shall not apply to school elections for officials of school districts;
- 18 (4) Vacancy in nomination means the circumstances in which the
- 19 nominee of a political party selected at a primary election shall not be
- 20 certified as the nominee due to death, resignation, withdrawal, or other good
- 21 and legal cause arising subsequent to nomination and preceding the final date
- 22 for certification of nominations;
- 23 (5) Vacancy in office means the vacancy in an elective office
- 24 created by death, resignation, or for other good and legal cause arising
- 25 subsequent to election to the office at a general or special election or
- 26 arising subsequent to taking office and prior to the expiration of the term
- 27 of office in those circumstances wherein the vacancy must be filled by a
- 28 special election rather than by appointment. The phrase vacancy in office
- 29 shall not apply to the election of a person at a general election to fill an
- 30 unexpired portion of a term of office;
- 31 (6) Majority party means that political party in the State of
- 32 Arkansas whose candidates were elected to a majority of the constitutional
- 33 offices of this state in the last-preceding general election;
- 34 (7) Minority party means that political party whose candidates were
- 35 elected to less than a majority of the constitutional offices of this state

         SECTION 2. Arkansas Code 7-5-107 is amended to read as follows:
         "7-5-107. Use of voter registration lists by election officials.

         In any election conducted in this state, precinct voter registration
18
19 lists shall be used by election officials in each precinct . Precinct voter
20 registration lists shall contain the name, address including zipcode, and
21 date of birth of each registered voter within the precinct including those
22 who have been designated inactive, the precinct number and county wherein the
23 precinct is located, the name and date of the election, and a space for the
24 voter's signature. The following shall be printed at the top of each page of
25 the precinct voter registration list:

- SECTION 8. Arkansas Code 7-5-314 is amended to read as follows:
- 31 "7-5-314. Duties of election clerks Voter lists Voters in line at
- 32 closing time.
- 33 (a) The election clerks in each precinct or at each box, shall mark
- 34 the voter's name, as having voted, on the precinct voter registration list
- 35 furnished by the clerk;

(b) If a voter's name does not appear on the precinct voter 2 registration list, the voter may only vote in accordance with Arkansas Code 3 **7-5-306**. (c) In all counties, when the polls close, all persons who have 5 presented themselves for voting and who are then in line at the polling place 6 shall be permitted to cast their votes. The election clerks shall then total 7 the number of voters on the voter lists, and such lists shall be certified by the election judges and attested by the election clerks." 9 SECTION 9. Arkansas Code 7-5-317 is amended to read as follows: 10 "7-5-317. Processing and delivery of election materials. 11 (a) After the count of the ballots is completed, all of the election 12 returns shall be processed and delivered in the following manner: (1) The list of voters form, the precinct voter registration 14 15 list, voter registration application forms and other record-keeping supplies 16 shall be delivered to the county clerk; (2) Certificates of election results and tally sheets: 17 (A) One (1) copy of the certificate of election results 18 19 shall be posted in a conspicuous place outside the polling place immediately 20 after the ballots are counted; 21 (B) One (1) copy of the certificate of election results 22 with one (1) copy of the tally sheets shall be delivered to the county clerk; (C) One (1) copy of the certificate of election results 23 24 shall be returned with one (1) copy of the tally sheets and reports of 25 challenges of voters, if any, to the county board of election commissioners 26 or, in a primary, the county committee. 27 (3) Ballots: (A) The election judges shall securely envelope the 28 29 ballots separately and place the ballots in a container with a numbered seal 30 and then deliver the ballots with the tally sheets and other election 31 materials to the county board of election commissioners or, in a primary, the 32 county committee; (B) All cancelled ballots shall be preserved separately 33 34 from the other ballots and returned to the county board of election

35 commissioners or, in a primary, the county committee.

- 1 (4) Stub boxes: Sealed stub boxes shall be delivered to the 2 county treasurer for storage.
- 3 (b) All of the election materials and returns shall be delivered by
- 4 the election judges within twenty-four (24) hours after the polls close to
- 5 the county board of election commissioners or, in a primary, the county
- 6 committee."

- 8 SECTION 10. Arkansas Code 7-7-308 is amended to read as follows:
- 9 "7-7-308. Determination of right to vote Precinct registration
- 10 lists.
- 11 (a) Before a person is permitted to vote, an election judge shall:
- 12 (1) Request the voter to identify himself in order to verify the
- 13 existence of his name on the precinct voter registration list;
- 14 (2) Request the voter, in the presence of the election judge, to
- 15 state his date of birth and address;
- 16 (3) Determine that the voter's date of birth and address are the
- 17 same as those on the precinct voter registration list;
- 18 (4) If the date of birth given by the voter is not the same as
- 19 that on the precinct voter registration list, request the voter to provide
- 20 identification as the election judge deems appropriate;
- 21 (5) If the voter's address is not the same as that on the
- 22 precinct voter registration list, verify with the county clerk that the
- 23 address is within the precinct. If the address is within the precinct,

- 21 and the county clerk is unable to verify the voter's registration and the

- 24 voter's registration status.
- 25 (e) The election judges and clerks shall indicate on the voters list
- 26 those persons who vote under these circumstances.

 2 returns and, where demanded, examined the ballots and upon having certified
 3 the results of the primary as required in this subchapter, shall file, in the
 4 office of the county clerk of the county and, where there is more than one
 5 (1) district, in the district of the county where the meetings of the county
 6 committee are held, all the returns, all _lists of voters_ forms, precinct
 7 voter registration lists, and all ballots, affidavits, and other documents
 8 received from the judges of election, and it shall be obligatory upon the
 9 committee, its chairman, and secretary.
- 10 (b) These materials shall be preserved by the county clerk for a
 11 period of two (2) years , subject to the orders of any court of competent

"(c) The county clerk shall furnish each county committee represented at the polling place one (l) copy of the appropriate precinct voter registration list to determine each person's right to vote in any party primary being conducted at the common polling place."

SECTION 13. Arkansas Code 7-7-504 is amended to read as follows:

21 "7-7-504. Registration files and voter lists.

- 22 (a) In voting machine counties where common polling places are
 23 established, the county clerk shall furnish each county committee represented
 24 at the polling place one (1) copy of the appropriate precinct voter
 25 registration list to determine each person's right to vote in any party
 26 primary being conducted at the common polling place.
- (b) Where separate polling places are established, a copy of the appropriate precinct voter registration list shall be delivered to each county committee by the county clerk."

SECTION 15. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

2	SECTION 16. If any provision of this act or the application thereof to
3	any person or circumstance is held invalid, such invalidity shall not affect
4	other provisions or applications of the act which can be given effect without
5	the invalid provision or application, and to this end the provisions of this
6	act are declared to be severable.

8	SECTION 17. All laws and parts of laws in conflict with this act are
9	hereby repealed.
