# A Bill

SENATE BILL 487

## For An Act To Be Entitled

8 "AN ACT TO PLACE THE RESPONSIBILITY IN THE STATE BUILDING  
9 SERVICES TO ADVERTISE FOR, RECEIVE AND OPEN AND QUALIFY  
10 BIDS FOR CONTRACTS FOR IMPROVEMENTS ON OR IN THE STATE  
11 CAPITOL BUILDING AND GROUNDS; AND FOR OTHER PURPOSES."

## Subtitle

14 "TO PLACE RESPONSIBILITY IN STATE  
15 BUILDING SERVICES FOR IMPROVEMENTS ON OR  
16 IN THE STATE CAPITOL BUILDING AND  
17 GROUNDS."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Effective July 1, 1995, it is the responsibility of State  
22 Building Services to advertise for and assist in the selection of an  
23 architect and/or engineering firm and also to advertise for and to receive,  
24 open and qualify bids for all construction or other improvements in or on the  
25 State Capitol Building and grounds.

26 For purposes of this act, the term "State Capitol Building and grounds"  
27 means the State Capitol Building, the Boiler House, and all parking lots  
28 located on the State Capitol grounds.

30 SECTION 2. The provisions of this act shall in no way diminish or  
31 otherwise affect the authority and responsibility of the Secretary of State  
32 to determine if and when any improvement will be undertaken in or on the  
33 State Capitol Building and grounds or to reject any bid or proposed contract  
34 with any contractor or any design professional for any construction project.

1           SECTION 3. All provisions of this act of a general and permanent  
2 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
3 Code Revision Commission shall incorporate the same in the Code.

5           SECTION 4. If any provision of this act or the application thereof to  
6 any person or circumstance is held invalid, such invalidity shall not affect  
7 other provisions or applications of the act which can be given effect without  
8 the invalid provision or application, and to this end the provisions of this  
9 act are declared to be severable.

10  
11           SECTION 5. All laws and parts of laws in conflict with this act are  
12 hereby repealed.
