## 7 For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 14-235-206 TO AUTHORIZE  
9 CITIES TO CHANGE THE NAME OF THEIR SEWER COMMITTEES TO  
10 WASTEWATER TREATMENT COMMITTEES; AND FOR OTHER PURPOSES."

### 12 Subtitle

13 "AN ACT TO AMEND ARKANSAS CODE 14-235-  
14 206 TO AUTHORIZE CITIES TO CHANGE THE  
15 NAME OF THEIR SEWER COMMITTEES TO  
16 WASTEWATER TREATMENT COMMITTEES."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. *Arkansas Code 14-235-206(a) is amended to read as follows:*  
21 "(a)(1)(A) *The construction, acquisition, improvement, equipment,*  
22 *custody, operation, and maintenance of any works for the collection,*  
23 *treatment, or disposal of sewage and the collection of revenue from it for*  
24 *the service rendered by it, shall be effected and supervised by a committee*  
25 *to be designated for that purpose by the municipal council.*

26 (B) *The committee will function under the control of the council*  
27 *to such extent as may be provided in the ordinance or resolution appointing*  
28 *the committee.*

29 (2) *The council may remove any member of the committee, with or*  
30 *without cause, and may appoint any substitute members in case of death,*  
31 *removal, or resignation.*

32 (3) *The committee will be called the sewer committee. Provided*  
33 *however, any city may by ordinance change the name of its sewer committee to*  
34 *wastewater treatment committee and in such instance the wastewater treatment*  
35 *committee shall have all powers, duties and functions prescribed by this*

1 chapter for wastewater treatment committees."

3 SECTION 2. All provisions of this act of a general and permanent  
4 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
5 Code Revision Commission shall incorporate the same in the Code.

7 SECTION 3. If any provision of this act or the application thereof to  
8 any person or circumstance is held invalid, such invalidity shall not affect  
9 other provisions or applications of the act which can be given effect without  
10 the invalid provision or application, and to this end the provisions of this  
11 act are declared to be severable.

12

13 SECTION 4. All laws and parts of laws in conflict with this act are  
14 hereby repealed.
