7 For An Act To Be Entitled

8 "AN ACT TO REDUCE THE SALES TAX ON USED MOTOR VEHICLES; TO
9 REPEAL THE MOTOR VEHICLE TRADE-IN CREDIT; AND FOR OTHER
10 PURPOSES."

12 Subtitle

13 "TO REDUCE THE SALES TAX ON USED MOTOR
14 VEHICLES AND TO REPEAL THE MOTOR VEHICLE
15 TRADE-IN CREDIT."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18

19 SECTION 1. Effective July 1, 1996, in lieu of the gross receipts tax
20 levied on a used motor vehicle, trailer or semitrailer pursuant to the
21 Arkansas Gross Receipts Tax (Arkansas Code § 26-52-101 et seq.) and the
22 Arkansas Compensating Use Tax (Arkansas Code § 26-53-101 et seq.) there shall
23 be levied an excise tax of two and one-half percent (2 1/2%) upon the gross
24 proceeds or gross receipts derived from all such sales.

26 SECTION 2. Effective July 1, 1996, for purposes of computing the
27 Arkansas Gross Receipts Tax (Arkansas Code § 26-52-101 et seq.) and the
28 Arkansas Compensating Use Tax (Arkansas Code § 26-53-101 et seq.) there shall
29 no longer be a reduction in the total consideration of a new or used motor
30 vehicle, trailer or semitrailer for a used motor vehicle, trailer or
31 semitrailer taken in trade as a credit or part payment on the sale of the new
32 or used motor vehicle, trailer, or semitrailer.

34 SECTION 3. Effective July 1, 1996, Arkansas Code § 26-52-510(b) and
35 §26-53-126(b) are repealed.

2 SECTION 4. All provisions of this act of a general and permanent
3 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
4 Code Revision Commission shall incorporate the same in the Code.

5

6 SECTION 5. If any provision of this act or the application thereof to
7 any person or circumstance is held invalid, such invalidity shall not affect
8 other provisions or applications of the act which can be given effect without
9 the invalid provision or application, and to this end the provisions of this
10 act are declared to be severable.

11

12 SECTION 6. All laws and parts of laws in conflict with this act are
13 hereby repealed.
