8 "AN ACT TO MAKE AN APPROPRIATION FOR EXPENSES FOR REPORTS
9 OF COLLEGE ACHIEVEMENT OF HIGH SCHOOL GRADUATES WHICH
10 SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS
11 APPROPRIATED BY ACT 1314 OF 1993; AND FOR OTHER PURPOSES."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the Department of Higher Education, to be payable from the Department of Higher Education Fund, for expenses for reports of college achievement of high school graduates which shall be supplemental and in addition to those funds appropriated in Section 9 of Act 1314 of 1993, the following:

SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal

1 control laws of this State, where applicable, and regulations promulgated by
2 the Department of Finance and Administration, as authorized by law, shall be
3 strictly complied with in disbursement of said funds.

4

5 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
6 Assembly that any funds disbursed under the authority of the appropriations
7 contained in this Act shall be in compliance with the stated reasons for
8 which this Act was adopted, as evidenced by the Agency Requests, Executive
9 Recommendations and Legislative Recommendations contained in the budget
10 manuals prepared by the Department of Finance and Administration, letters, or
11 summarized oral testimony in the official minutes of the Arkansas Legislative
12 Council or Joint Budget Committee which relate to its passage and adoption.

14 SECTION 4. CODE. All provisions of this Act of a general and
15 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and
16 the Arkansas Code Revision Commission shall incorporate the same in the Code.

17

18 SECTION 5. SEVERABILITY. If any provision of this Act or the
19 application thereof to any person or circumstance is held invalid, such
20 invalidity shall not affect other provisions or applications of the Act which
21 can be given effect without the invalid provision or application, and to this
22 end the provisions of this Act are declared to be severable.

23

24 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
25 with this Act are hereby repealed.

26

27 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
28 Eightieth General Assembly, that funds provided by the General Assembly for
29 the expenses for reports of college achievement of high school graduates of
30 the Department of Higher Education are, due to unforeseen circumstances,
31 insufficient for the Department of Higher Education to meet the needs of this
32 program; that the provisions of this act will provide the necessary monies
33 for the Department of Higher Education to continue such services; and that a
34 delay in the effective date of this act could work irreparable harm upon the
35 proper administration and provision of essential governmental programs.

1 Therefore, an emergency is hereby declared to exist and this Act being
2 necessary for the immediate preservation of the public peace, health and
3 safety shall be in full force and effect from and after its passage and
4 approval.
