8 "AN ACT TO AMEND ARKANSAS CODE 12-30-204 RELATING TO THE
9 PURCHASE OF PRISON MADE GOODS BY PUBLIC AGENCIES; TO
10 REPEAL ARKANSAS CODE 12-30-208 WHICH REQUIRES STATE
11 AGENCIES TO ESTIMATE THE QUANTITY OF PRISON MADE GOODS
12 AGENCIES WILL NEED EACH FISCAL YEAR; AND FOR OTHER
13 PURPOSES."

Subtitle

16 "RELATING TO THE PURCHASE OF PRISON MADE
17 GOODS BY PUBLIC AGENCIES."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20

21 SECTION 1. Arkansas Code 12-30-204 is amended to read as follows:
22 "12-30-204. Purchase of goods by state and local agencies.

23 (a) All offices, departments, institutions, and agencies of this state
24 which are supported in whole or in part by this state , and all political
25 subdivisions of this state may purchase, from the State Board of Correction,
26 any products required by the offices, departments, institutions, agencies, or
27 political subdivisions of this state, produced or manufactured by the
28 Department of Correction utilizing prison labor as provided for by this
29 subchapter.

30 (b) Such offices, departments, institutions, and agencies shall submit
31 an Invitation for Bid to the State Board of Correction for all products known
32 to be produced or manufactured by the Department of Correction utilizing
33 prison labor as provided for by this subchapter.

34 (c) Any bid submitted pursuant to subsection (b) shall be analyzed to
35 determine if it is consistent with bid requirements and competitive with

1 other bids submitted thereunder.

2 (d) All purchases made pursuant to this act shall be made through the
3 Department of Correction purchasing department, upon requisition by the
4 proper authority of the office, department, institution, agency, or political
5 subdivision of this state requiring the articles or products."

7 SECTION 2. Arkansas Code 12-30-208 is hereby repealed.

8

9 SECTION 3. All provisions of this act of a general and permanent
10 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
11 Code Revision Commission shall incorporate the same in the Code.

12

13 SECTION 4. If any provision of this act or the application thereof to
14 any person or circumstance is held invalid, such invalidity shall not affect
15 other provisions or applications of the act which can be given effect without
16 the invalid provision or application, and to this end the provisions of this
17 act are declared to be severable.

18

19 SECTION 5. All laws and parts of laws in conflict with this act are
20 hereby repealed.
