7 For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED 15-23-313 (a)(1)
9 TO FURTHER DEFINE THAT PORTION OF THE SALINE RIVER
10 DESIGNATED AS A COMPONENT OF THE NATURAL AND SCENIC RIVERS
11 SYSTEM; AND FOR OTHER PURPOSES."

13 Subtitle

14 "TO DEFINE THAT PORTION OF THE SALINE
15 RIVER DESIGNATED AS A COMPONENT OF THE
16 NATURAL AND SCENIC RIVERS SYSTEM."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 SECTION 1. Arkansas Code Annotated 15-23-313(a)(1) is amended to read
21 as follows:

22 "(a)(1) Notwithstanding any other provisions of this subchapter, the
23 following segments of rivers or streams are designated as components of the
24 Arkansas Natural and Scenic Rivers System:

25 (A) The Cossatot River, from Gillham Reservoir, Section 8,
26 Township 5 South, Range 30 West, upstream to its headwaters near Baker
27 Mountain, South Line of Section 15, Township 3 South, Range 30 West;

28 (B) The Strawberry River, from the line dividing Sharp County
29 and Izard County, Section 12, Township 17 North, Range 7 West, upstream to
30 its headwaters near Byron, North Line of Section 3, Township 19 North, Range
31 9 West;

32 (C) The Saline River, from its confluence with the Ouachita
33 River, Section 9, Township 18 South, Range 10 West, upstream to headwaters in
34 Saline and Garland Counties, including all forks and all major tributaries of
35 such forks; and

1 (D) The Little Missouri River, from the upper end of Lake
2 Greeson, South Line of Section 31, Township 5 South, Range 26 West, upstream
3 to its headwaters south of Big Fork, Center of Section 32, Township 3 South,
4 Range 28 West."

5

6 SECTION 2. All provisions of this act of a general and permanent
7 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
8 Code Revision Commission shall incorporate the same in the Code.

9

10 SECTION 3. If any provision of this act or the application thereof to
11 any person or circumstance is held invalid, such invalidity shall not affect
12 other provisions or applications of the act which can be given effect without
13 the invalid provision or application, and to this end the provisions of this
14 act are declared to be severable.

15

16 SECTION 4. All laws and parts of laws in conflict with this act are
17 hereby repealed.
