7 For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 16-93-201 TO PROVIDE THAT
9 THE POST PRISON TRANSFER BOARD WILL BE COMPOSED OF FIVE
10 FULL-TIME MEMBERS AND TWO PART-TIME MEMBERS INSTEAD OF
11 THREE FULL-TIME MEMBERS AND FOUR PART-TIME MEMBERS; AND
12 FOR OTHER PURPOSES."

14 Subtitle

15 "TO PROVIDE THAT THE POST PRISON
16 TRANSFER BOARD WILL BE COMPOSED OF FIVE
17 FULL-TIME MEMBERS AND TWO PART-TIME
18 MEMBERS INSTEAD OF THREE FULL-TIME
19 MEMBERS AND FOUR PART-TIME MEMBERS."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22

23 *SECTION 1. Arkansas Code 16-93-201 is amended to read as follows:*
24 *"16-93-201. Creation - Members.*

25 *(a) There is hereby created the Post Prison Transfer Board to be
26 composed of seven (7) members to be appointed, from the state at-large, by
27 the Governor and confirmed by the Senate. Five (5) members shall be full-
28 time officials of this state, one of which shall be designated by the
29 Governor as the chairman of the Board. The terms of office of two (2) of the
30 four (4) part-time members serving on January 1, 1995, shall expire on the
31 effective date of this 1995 act. The Governor shall designate the two (2)
32 members whose terms shall expire and shall appoint two (2) full-time members
33 to replace them. Members shall serve seven (7) year terms except that the
34 terms shall be staggered by the Governor so that the term of one member
35 expires each year.*

1 (b) If any vacancy shall occur on the Post Prison Transfer Board prior
2 to the expiration of a term, the Governor shall fill the vacancy for the
3 remainder of the unexpired term, subject to confirmation by the Senate at its
4 next regular session.

5 (c) The two (2) part-time members of the Post Prison Transfer Board
6 shall receive the same amount per day as is paid to the members of the
7 Arkansas Board of Correction and Community Punishment for each day they are
8 actually engaged in attending the official board meetings or official board
9 business. In addition, those two (2) members shall be entitled to be
10 compensated for actual expenses incurred in the attendance of such meetings
11 or business and shall be entitled to be compensated for mileage at the same
12 rate authorized by state travel regulations for state employees for each mile
13 traveled in attending official board meetings or board business.

14 (d) Four (4) members of the Post Prison Transfer Board shall
15 constitute a quorum."

16

17 SECTION 2. All provisions of this act of a general and permanent
18 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
19 Code Revision Commission shall incorporate the same in the Code.

20

21 SECTION 3. If any provision of this act or the application thereof to
22 any person or circumstance is held invalid, such invalidity shall not affect
23 other provisions or applications of the act which can be given effect without
24 the invalid provision or application, and to this end the provisions of this
25 act are declared to be severable.

26

27 SECTION 4. All laws and parts of laws in conflict with this act are
28 hereby repealed.

29

30 SECTION 5. It is hereby found and determined by the General Assembly
31 that it is essential to the effective and efficient operation of the Post
32 Prison Transfer Board that the full time membership of the board be increased
33 from three to five and the part time membership be reduced to two; that this
34 act is designed to make such urgent and necessary revision in the membership
35 of the board and should be given effect immediately. Therefore, an emergency

1 is hereby declared to exist and this act being necessary for the immediate
2 preservation of the public peace, health and safety shall be in full force
3 and effect from and after its passage and approval.
