8 "AN ACT TO AMEND ARKANSAS CODE 6-17-807 TO PROVIDE THAT IF
9 THE DEPARTMENT OF EDUCATION PRESCRIBES ADDITIONAL TIME TO
10 BE ADDED TO THE REQUIRED INSTRUCTION TIME DURING ANY
11 SCHOOL DAY OR SCHOOL WEEK, THE TEACHERS SHALL RECEIVE
12 INCREASED COMPENSATION; AND FOR OTHER PURPOSES."

15 "IF DEPARTMENT OF EDUCATION PRESCRIBES
16 ADDITIONAL INSTRUCTION TIME TO BE ADDED
17 DURING ANY SCHOOL DAY OR WEEK, TEACHERS
18 SHALL RECEIVE INCREASED COMPENSATION."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21

22 SECTION 1. Arkansas Code 6-17-807 is amended to read as follows:
23 "6-17-807. Additional days.

24 (a) If additional days are added to a teacher's contract or if the
25 teacher is required to work more days than provided for under the teacher's
26 contract, then the teacher's pay under the contract shall be increased
27 proportionately so that the teacher will receive pay for each day added to
28 the contract or each additional day the teacher is required to work at no
29 less than the daily rate paid to the teacher under the teacher's contract.

30 (b) If additional time is added to the required planned instructional
31 time in each school day, as specified by the State Department of Education,
32 such that the school day will average more than six (6) hours per day or
33 thirty (30) hours per week, the teacher's pay shall be increased
34 proportionately so that the teacher will receive pay for the additional time
35 added to the day."

2 SECTION 2. All provisions of this act of a general and permanent
3 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
4 Code Revision Commission shall incorporate the same in the Code.

5

6 SECTION 3. If any provision of this act or the application thereof to
7 any person or circumstance is held invalid, such invalidity shall not affect
8 other provisions or applications of the act which can be given effect without
9 the invalid provision or application, and to this end the provisions of this
10 act are declared to be severable.

11

12 SECTION 4. All laws and parts of laws in conflict with this act are
13 hereby repealed.
