6 **For An Act To Be Entitled**
7 "AN ACT TO MAKE AN APPROPRIATION FOR OPERATING EXPENSES
8 FOR THE ARKANSAS PUBLIC SERVICE COMMISSION - ASSESSMENT
9 COORDINATION DIVISION WHICH SHALL BE SUPPLEMENTAL AND IN
10 ADDITION TO THOSE FUNDS APPROPRIATED IN SECTION 11 OF ACT
11 98 OF 1995 FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1997;
12 AND FOR OTHER PURPOSES."

15 "AN ACT TO MAKE A SUPPLEMENTAL APPROPRIATION FOR THE
16 ARKANSAS PUBLIC SERVICE COMMISSION - ASSESSMENT
17 COORDINATION DIVISION."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. APPROPRIATIONS - ASSESSMENT COORDINATION DIVISION. There is
22 hereby appropriated, to the Arkansas Public Service Commission, to be payable
23 from the State General Services Fund Account, for payment of professional
24 recognition payments to county assessors and their employees through the
25 Assessment Education Incentive Program of the Arkansas Public Service
26 Commission - Assessment Coordination Division which shall be supplemental and
27 in addition to those funds appropriated in Section 11 of Act 98 of 1995 for
28 the biennial period ending June 30, 1997, the following:

1 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
2 authorized by this Act shall be limited to the appropriation for such agency
3 and funds made available by law for the support of such appropriations; and
4 the restrictions of the State Purchasing Law, the General Accounting and
5 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
6 Procedures and Restrictions Act, or their successors, and other fiscal
7 control laws of this State, where applicable, and regulations promulgated by
8 the Department of Finance and Administration, as authorized by law, shall be
9 strictly complied with in disbursement of said funds.

11 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
12 Assembly that any funds disbursed under the authority of the appropriations
13 contained in this Act shall be in compliance with the stated reasons for
14 which this Act was adopted, as evidenced by the Agency Requests, Executive
15 Recommendations and Legislative Recommendations contained in the budget
16 manuals prepared by the Department of Finance and Administration, letters, or
17 summarized oral testimony in the official minutes of the Arkansas Legislative
18 Council or Joint Budget Committee which relate to its passage and adoption.

20 SECTION 4. CODE. All provisions of this Act of a general and
21 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and
22 the Arkansas Code Revision Commission shall incorporate the same in the Code.

23

24 SECTION 5. SEVERABILITY. If any provision of this Act or the
25 application thereof to any person or circumstance is held invalid, such
26 invalidity shall not affect other provisions or applications of the Act which
27 can be given effect without the invalid provision or application, and to this
28 end the provisions of this Act are declared to be severable.

29

30 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
31 with this Act are hereby repealed.

33 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
34 Eightieth General Assembly, that the funds provided previously by the
35 Eightieth General Assembly for the operations of the Arkansas Public Service

1 Commission-Assessment Coordination Division, due to unforeseen circumstances,
2 are insufficient for the Arkansas Public Service Commission-Assessment
3 Coordination Division to continue to provide essential governmental services;
4 that the provisions of the act will provide the necessary monies for the
5 Arkansas Public Service Commission-Assessment Coordination Division to
6 continue such services, and that a delay in the effective date of this Act
7 could work irreparable harm upon the proper administration and provision of
8 essential governmental programs. Therefore, an emergency is hereby declared
9 to exist and this Act being necessary for the immediate preservation of the
10 public peace, health and safety shall be in full force and effect from and
11 after July 1, 1995.
