7 **For An Act To Be Entitled**
8 "AN ACT TO AMEND THE DEPARTMENT OF HUMAN SERVICES _
9 RENOVATION FUND TO MAKE THE FUNDS AVAILABLE TO ALL
10 DIVISIONS OF THE DEPARTMENT; AND FOR OTHER PURPOSES."

12 **Subtitle**

13 "AN ACT TO AMEND THE DEPARTMENT OF HUMAN
14 SERVICES _ RENOVATION FUND TO MAKE THE
15 FUNDS AVAILABLE TO ALL DIVISIONS OF THE
16 DEPARTMENT."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19

20 SECTION 1. Arkansas Code 19-5-1020(c) is hereby amended to read as
21 follows:

22 "(c) The fund shall consist of:

23 (1) Federal reimbursement received by the Department of Human
24 Services and deposited in the various fund accounts of the department; and
25 (2) Any unappropriated balance remaining in the Mental
26 Retardation - Developmental Disabilities Services - Intermediate Care
27 Facility Renovation Fund.

28 (3) Other funds as may be available within the Department of
29 Human Services that can be used for the purposes of this fund."

30

31 SECTION 2. All provisions of this act of a general and permanent
32 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
33 Code Revision Commission shall incorporate the same in the Code.

34

35 SECTION 3. If any provision of this act or the application thereof to

1 any person or circumstance is held invalid, such invalidity shall not affect
2 other provisions or applications of the act which can be given effect without
3 the invalid provision or application, and to this end the provisions of this
4 act are declared to be severable.

5

6 SECTION 4. All laws and parts of laws in conflict with this act are
7 hereby repealed.

8

9 SECTION 5. EMERGENCY. It is hereby found and determined by the
10 General Assembly that the present law pertaining to the Department of Human
11 Services Renovation Fund does not allow the transfer of general revenue or
12 other non-federal funds into the Renovation Fund; that divisions of the
13 Department of Human Services which do not receive federal reimbursement for
14 construction or renovation cannot use the fund; that this act is designed to
15 allow all divisions of the Department of Human Services to transfer funds
16 into the Renovation Fund and use them; and for effective administration of
17 this act it should become effective immediately. Therefore, an emergency is
18 hereby declared to exist and this act being necessary for the immediate
19 preservation of the public peace, health and safety shall be in full force
20 and effect from and after its passage and approval.
