## 7 For An Act To Be Entitled

8 "AN ACT TO CREATE A COMMISSION ON LIBRARY LAWS; AND FOR  
9 OTHER PURPOSES."

## 11 Subtitle

12 "AN ACT TO CREATE A COMMISSION ON  
13 LIBRARY LAWS."

14

15 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

16

17 SECTION 1. (a) A Commission on Library Laws is created and shall be  
18 composed of seventeen (17) members to be appointed by the Governor as  
19 follows:

20 (1) Five (5) shall be library directors, one from each of the  
21 state's five (5) library development districts;

22 (2) Four (4) shall be citizens who are interested in and  
23 knowledgeable about library services;

24 (3) Two (2) shall be representatives of municipal government;

25 (4) Two (2) shall be representatives of county government;

26 (5) One (1) shall be the state librarian or designee;

27 (6) One (1) shall be a trustee from a library or library system  
28 that serves more than fifty thousand (50,000) people;

29 (7) One (1) shall be a trustee from a library or library system  
30 that serves less than fifty thousand (50,000) people;

31 (8) One (1) shall be an attorney who is knowledgeable about  
32 municipal and county law.

33 (b) The governor shall make the appointments and select the  
34 chairperson from the commission membership no later than January 1, 1996.

35 (c) The Commission shall hold its first meeting during January, 1996

1 at a time and place designated by the chairperson. Subsequent meetings will  
2 be held at the call of the chairperson or upon the written request of five  
3 (5) members of the commission.

4 (d) The Governor may remove any commission member for incapacity,  
5 incompetence, neglect of duty or malfeasance in office.

6 (e) The Governor shall fill any vacancy from a list of at least two  
7 (2) qualified candidates submitted within fifteen (15) days of the vacancy by  
8 the commission. The Governor shall make the appointment within fifteen (15)  
9 days after the commission has submitted the candidates' names.

10 (f) The members shall serve without compensation, but may be  
11 reimbursed to the extent monies are available for actual and necessary  
12 expenses incurred in the performance of their duties.

13

14 SECTION 2. (a) The Commission on Library Laws shall study existing  
15 laws of the state that affect the operation and development of public and  
16 regional libraries for the purpose of developing a Model Library Law. The  
17 Model Library Law shall define the relationship of the library to the  
18 municipality and county in which it is located and may also address any other  
19 aspect of law that the commission deems appropriate for the future  
20 development of effective library services in this state.

21 (b) The Commission on Library Laws shall hold public hearings, may  
22 hire staff and consultants as monies are available, and may solicit, accept,  
23 retain and administer gifts, grants or donations of money, services or  
24 property.

25 (c) The Commission shall report its findings and make its  
26 recommendations to the Governor and the Bureau of Legislative Research by  
27 January 1, 1997.

28

29 SECTION 3. All provisions of this act of a general and permanent  
30 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
31 Code Revision Commission shall incorporate the same in the Code.

32

33 SECTION 4. If any provision of this act or the application thereof to  
34 any person or circumstance is held invalid, such invalidity shall not affect  
35 other provisions or applications of the act which can be given effect without

1 the invalid provision or application, and to this end the provisions of this  
2 act are declared to be severable.

3

4 SECTION 5. All laws and parts of laws in conflict with this act are  
5 hereby repealed.
