8                   *TO PROVIDE FOR AN EXTENSION OF THE REGULAR SESSION OF THE*  
9                   *EIGHTIETH GENERAL ASSEMBLY UNTIL 12:00 NOON, APRIL 28,*  
10                  *1995; TO PROVIDE FOR RECESS OF THE EIGHTIETH GENERAL*  
11                  *ASSEMBLY AT THE CLOSE OF BUSINESS ON APRIL 7, 1995; TO*  
12                  *AUTHORIZE THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND*  
13                  *THE PRESIDENT PRO TEMPORE OF THE SENATE BY JOINT*  
14                  *PROCLAMATION TO RECONVENE THE GENERAL ASSEMBLY BEFORE*  
15                  *12:00 NOON APRIL 28, 1995 FOR THE PURPOSE OF CONSIDERING*  
16                  *VETOES AND CORRECTING ERRORS OR OVERSIGHTS OR TO ADJOURN*  
17                  *THE EIGHTIETH GENERAL ASSEMBLY AT ANY TIME BEFORE THAT*  
18                  *DATE IF THEY DETERMINE THAT THERE IS NO NEED TO RECONVENE;*  
19                  *TO PROVIDE THAT IF THE GENERAL ASSEMBLY IS NOT RECONVENED*  
20                  *OR ADJOURNED BEFORE 12:00 NOON APRIL 28, 1995, IT IS*  
21                  *ADJOURNED SINE DIE ON THAT DATE.*

24                   *FOR A RECESS OF THE EIGHTIETH GENERAL ASSEMBLY.*

26                  WHEREAS, Section 17 of Article V of the Constitution of the state of  
27 Arkansas provides that the regular biennial session of the General Assembly  
28 shall not exceed sixty days in duration, unless extended by a vote of  
29 two-thirds of the members elected to each house of the General Assembly; and

30                  WHEREAS, it now appears that the regular session of the Eightieth  
31 General Assembly will be unable to complete the essential business of this  
32 session within sixty days, and that an extension of this regular session will  
33 be necessary for the completion of the business of this session,

## 1 NOW THEREFORE,

2 BE IT RESOLVED BY THE SENATE OF THE EIGHTIETH GENERAL ASSEMBLY OF THE STATE  
3 OF ARKANSAS, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

5       *The regular session of the Eightieth General Assembly of the State of*  
6 *Arkansas is hereby extended until 12:00 noon, April 28, 1995.*

*The regular session of the Eightieth General Assembly of the State of Arkansas shall enter into recess at the close of business on April 7, 1995.*

9           *The Speaker of the House of Representatives and the President Pro  
10 Tempore of the Senate may, by joint proclamation, reconvene the General  
11 Assembly before 12:00 noon, April 28, 1995, for the purpose of considering  
12 executive vetoes and correcting errors and oversights or may adjourn the  
13 General Assembly any time before that date if they determine it is not  
14 necessary to reconvene. If the General Assembly is not reconvened before  
15 12:00 noon, April 28, 1995, the regular session of the Eightieth General  
16 Assembly is hereby adjourned sine die on that date.*
