20 WHEREAS, Dr. Glen Cochran served as consultant and coordinator for the
21 Governor's Task Force To Study Arkansas School Funding prior to the convening
22 of the Eightieth General Assembly of the State of Arkansas; and

24 WHEREAS, Dr. Glen Cochran is Professor Emeritus at the University of
25 Arkansas, where he taught educational administration from 1965 until 1990,
26 creating a lasting impact on public education; and

28 WHEREAS, Dr. Glen Cochran served as Co-Director of the Governor's
29 School Finance Committee in 1983 when the Seventy-Fourth General Assembly
30 revised the method for funding public education; and

32 WHEREAS, Dr. Glen Cochran gave unselfishly of his time and energy for
33 many months in assisting members of the Governor's Task Force and other
34 members of the Eightieth General Assembly in efforts to develop an equitable,
35 suitable, and efficient system of public education; and

2 WHEREAS, Dr. Glen Cochran's knowledge and expertise contributed to the
3 legislation that emerged as Act 917 of 1995; and

5 WHEREAS, Dr. Glen Cochran's legacy to the school children of Arkansas
6 is an educational system that will prepare them for productive citizenship in
7 the 21st Century.
