19                  WHEREAS, Detective Frederick E. Lee, of the City of Little Rock,  
20 Pulaski County, Arkansas was critically wounded in the course of carrying out  
21 his sworn duty to enforce the laws of the State of Arkansas on Tuesday,  
22 February 7, 1995; and

24                  WHEREAS, Frederick E. Lee, age twenty-six years, a Police Detective  
25 with Little Rock Police Department, was shot while serving a search warrant  
26 in a narcotics investigation and now recovering from his wounds; and

28                  WHEREAS, Detective Frederick E. Lee served his community with bravery  
29 and distinction and he has paid severely for his service with serious  
30 physical pain from his wounds; and

32                  WHEREAS, Detective Frederick E. Lee should be commended for his  
33 physical sacrifice and thanked by his fellow policemen, his fellow citizens  
34 of the City, and his fellow Arkansans for his service in keeping the peace  
35 and enforcing the rule of law in our community and our State,

2 NOW THEREFORE,

3 BE IT RESOLVED BY THE SENATE OF THE EIGHTIETH GENERAL ASSEMBLY OF THE STATE  
4 OF ARKANSAS, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

6 That this Resolution is adopted in honor of Police Detective Frederick  
7 E. Lee of the Little Rock Police Department in recognition for his bravery  
8 and his physical pain and in thanks for his service to the people of the City  
9 of Little Rock, and the State of Arkansas, and to his fellow man and is  
10 adopted in the hope that his recovery from his wounds is both quick and  
11 complete; and

13 BE IT FURTHER RESOLVED that upon adoption of this Resolution, an  
14 appropriate copy hereof and a Citation commending his bravery and service  
15 shall be transmitted and presented to Detective Frederick E. Lee.
