17 WHEREAS, Detective Joseph T. Fisher, of the City of Little Rock,  
18 Pulaski County, Arkansas, died in the course of carrying out his sworn duty  
19 to enforce the laws of the State of Arkansas on Tuesday, February 7, 1995;

21 WHEREAS, Joseph Tucker Fisher, age thirty-four, a Police Detective with  
22 Little Rock Police Department, was fatally wounded while serving a search  
23 warrant in a narcotics investigation; and

24 WHEREAS, Detective Joseph T. Fisher is survived by his two children, a  
25 daughter Brook, and a daughter Britta; and

26 WHEREAS, Detective Joseph T. Fisher served his community with bravery  
27 and distinction and paid the ultimate sacrifice for his fellow policemen, his  
28 City, and his fellow Arkansans with service to preserve the peace and to  
29 enforce the rule of law in our community and State,

32 BE IT RESOLVED BY THE SENATE OF THE EIGHTIETH GENERAL ASSEMBLY OF THE STATE  
33 OF ARKANSAS:

35 That this Resolution is adopted in respectful memory of Detective

1 Joseph T. Fisher of the Little Rock Police Department in recognition of the  
2 ultimate contribution he made to the people of the City of Little Rock, and  
3 the State of Arkansas, and to his fellowman; and
