         SECTION 1. Arkansas Code 10-3-203(3)(A), first paragraph, is amended

         "(3)(A) The following ten (10) subject matter interim committees of

28 of the twenty (20) members of the House of Representatives and the Senate
29 committees to each consist of the seven (7) members of the Senate who compose
30 the respective standing committees of the House and Senate having comparable
31 subject matter jurisdiction, plus such other non-voting members as may be
32 selected pursuant to rules of the House of Representatives and the Senate who
33 shall be entitled to per diem and mileage for attending meetings of the
34 committees. The respective House and Senate committees may meet separately
35 or the House and Senate committees of comparable subject matter jurisdiction

              The Director of the Bureau of Legislative Research shall have the

- 23 committee to meet in excess of twelve (12) days per year, it shall report the

1 Legislative Council shall be the disbursing officer of the funds appropriated 2 for paying per diem, expenses, and mileage to members of the General Assembly 3 attending regular and special meetings and other committee-related activities 4 of the interim committees of the General Assembly as provided by law, unless 5 specific provisions are made to the contrary. (b) Payments for per diem and mileage for attendance by members of the 7 Senate and House of Representatives at meetings of interim committees shall 8 be upon written claims filed therefor." 9 SECTION 7. Arkansas Code 10-3-210(a) is amended to read as follows: 10 "(a) Members of the interim committees may be authorized to attend 12 regional or national conferences of legislators or other public officials 13 where attendance thereat will serve a beneficial legislative purpose. Members 14 shall be entitled to receive reimbursement for reasonable and necessary 15 expenses for travel, meals, lodging, and other authorized expenses incurred 16 in connection therewith." 17 SECTION 8. Arkansas Code 10-3-212(b) is amended to read as follows: 18 "(b) The members of the two (2) committees shall be entitled to 19 20 receive per diem at the rate set for attendance at meetings of the subject 21 matter interim committees of the House and Senate for attending joint or separate meetings of the committees. Members shall also be entitled to 23 mileage reimbursement as provided by law." 2.4 2.5 SECTION 9. Arkansas Code 10-3-214(a) is amended to read as follows: "(a) In addition to the functions and duties of the Legislative 26 Council which are prescribed by law, it shall be the responsibility of the 28 Legislative Council, in order to coordinate the efforts of the interim 29 committees and to avoid duplication of effort by such committees, to review 30 and screen all study resolutions referred by the General Assembly and all 31 study proposals sponsored by members of the General Assembly during the 32 interim and approved by the Legislative Council. It shall either refer the 33 study resolutions or study proposals to the appropriate interim committee for 34 study or, in unusual cases, retain the study proposal or resolution and 35 conduct the study. Nothing in this act, however, shall be construed to alter

1 or diminish the exclusive interim and presession budget jurisdiction and 2 authority of the Legislative Council as now prescribed by law." 3

SECTION 10. Arkansas Code 10-3-215 is amended to read as follows: 4 "10-3-215. Study expenses.

5 (a)(1) Whenever an interim committee of the Arkansas General Assembly deems it necessary or advisable, in connection with any interim study 8 activity authorized by law or undertaken by the committee, to hire 9 consultants, actuaries, special technical or clerical employees, or other 10 assistance in connection with any such study, a written request shall be 11 filed with the Legislative Council. This request shall outline the nature or 12 purposes of the study, the need or necessity of hiring such special 13 consultants, actuaries, technical or clerical employees, or other assistance, 14 and the estimated amount required for the assistance.

15 (2) If the Legislative Council deems that uncommitted funds are 16 available for that purpose and that the request for funds for hiring 17 consultants, actuaries, technical or clerical employees, or other assistance 18 will serve a useful purpose and that the cost is justified, the Legislative 19 Council, after seeking the advice of the interim committee which made the 20 request, may proceed to employ such consultants, actuaries, technical or 21 clerical employees, or provide other assistance and may make payment from the 22 funds appropriated for interim committee study expenses.

The Legislative Council may use the funds appropriated for interim 23 committee study expenses in the same manner as other interim committees, as 2.4 set out in this section. 25

It is the intent of the procedures set out in this section that 26 the Legislative Council shall coordinate, control, and authorize expenditures for interim committee study expenses whenever the Legislative Council deems 29 the expenditures to be in the interest of comprehensive studies or research projects authorized by law or by appropriate action taken by the respective 31 interim committees."

SECTION 11. Arkansas Code 10-3-217 is amended to read as follows: 33 "10-3-217. Proposed bills - Filing - Action by committee. 34

(a) For the purpose of expediting the work of the interim committees

- 1 of the General Assembly and to encourage each committee to develop bills for
- 2 prompt introduction upon the convening of each session of the General
- 3 Assembly, any member of the General Assembly may file drafts of proposed
- 4 bills for consideration by the appropriate germane interim committee for
- 5 study, review, modification, and action thereon by such committee. In
- 6 addition, interim committees may cause drafts of bills to be prepared to
- 7 carry out the findings and recommendations of the interim committees which
- 8 result in recommendations for corrective or remedial legislation to be
- 9 submitted to the next-following session of the General Assembly.
- 10 (b) Proposed bills may be filed with interim committees as follows:
- 11 (1) By a member of the General Assembly filed directly with the
- 12 interim committee of which he is a member if the bill is germane to such
- 13 committee;
- 14 (2) By a member of the General Assembly filed with the
- 15 Legislative Council for referral to the appropriate interim committee of the
- 16 General Assembly;
- 17 (3) By the Governor or a state agency filed with the appropriate
- 18 germane interim committee or filed with the Legislative Council for referral
- 19 to the germane interim committee for study and review.
- 20 (c) All bills presented by the Governor and state agencies for interim
- 21 committee study shall be approved for study only upon a majority vote of the
- 22 committee, without that action creating a presumption of favorable action by
- 23 the committee on the bill, upon conclusion of its study.
- 24 (d) Bills filed directly with an interim committee shall be reviewed
- 25 by the Legislative Council for the purpose of determining that the bill is
- 26 germane to the committee, and may be re-referred to the germane interim
- 27 committee if the Legislative Council determines that the bill is not germane
- 28 to the committee with which filed.
- 29 (e) Upon conclusion of its study and hearings on a proposed bill, the
- 30 committee shall take action as follows:
- 31 (1) Upon the favorable vote of a majority of the members of the
- 32 committee or if the committee is meeting as a joint committee of the House of
- 33 Representatives and the Senate, then upon the favorable vote of a majority of
- 34 the Senate members of the committee and a majority of the House members of
- 35 the committee, approve the bill, including any amendments that may be agreed

1 to by the committee, for prefiling as a committee bill with the next 2 following regular session of the General Assembly; or 3 (2) Reject the proposed bill as a committee bill; or (3) Take no action thereon. 4 Any bill approved by an interim committee, whether a committee of 6 one house or a joint meeting of committees of both houses, for introduction 7 at the next regular session of the General Assembly shall be prefiled as a 8 committee bill by either the House chairman or the Senate chairman of the 9 committee in the manner provided for prefiling of bills preceding the 10 convening of each regular session of the General Assembly. However, the 11 prefiling of the bill in the House of Representatives and the Senate by the 12 chairman or cochairmen of the interim committee as a committee bill shall be 13 solely for the purpose of presenting the bill to the next regular session of 14 the General Assembly for consideration in the manner provided in the rules of 15 the respective houses. The bill shall be considered by each house and by the 16 appropriate committee thereof in the same manner as other bills are considered by the General Assembly. (g) In the event an interim committee rejects a bill or fails to take 18 19 action thereon, any member of the General Assembly may introduce the bill at 20 the next regular session of the General Assembly, and the bill shall be 21 considered in the same manner as other bills introduced in the House of 22 Representatives or the Senate." 23 SECTION 12. Arkansas Code 10-3-218(b) is amended to read as follows: 2.4 25 "(b) All members of the Senate and House of Representatives who will 26 be serving in the upcoming regular biennial session of the General Assembly, including the newly elected members of the Senate and House of 28 Representatives, shall be entitled to attend any or all biennial presession 29 budget hearings conducted by the Legislative Council and the Joint Budget 30 Committee and shall be entitled to receive per diem and mileage for attending 31 such meetings at the same rate as is provided for attendance at meetings of 32 interim committees of the General Assembly." 33 SECTION 13. Arkansas Code 10-3-219 is amended to read as follows: 34 "10-3-219. Purpose of §§ 10-3-217 and 10-3-218. 35

It is the intent of §§ 10-3-217 and 10-3-218 to supplement the existing 2 laws of this state governing the powers, functions, and duties of the joint 3 interim committees of the General Assembly. Nothing in those sections is 4 intended to modify or repeal any of the existing laws governing the powers, 5 functions, and duties of any of the joint interim committees of the General 6 Assembly, including the Legislative Council and the Legislative Joint 7 Auditing Committee, except to provide for separate interim committees of the 8 House of Representatives and the Senate and to authorize comparable House and 9 Senate committees to meet jointly during the interim if they choose to do 10 so." 11 SECTION 14. Arkansas Code 10-3-220(b) is amended to read as follows: 12 "(b) The director shall report his findings annually to the Committee 13 on Revenue and Taxation of the House of Representatives and of the Senate and 15 may make such other reports to the committees as he deems necessary." 16 SECTION 15. As soon as possible after the effective date of this act 17 and from time to time thereafter, the chairman and vice chairman of the 19 Legislative Council, the Speaker of the House of Representatives, and the 20 President Pro Tempore of the Senate, meeting jointly with the chairman of the 21 Joint Budget Committee shall determine the distribution of funds appropriated 22 for ad interim committees' per diem, mileage, and out-of-state travel to the 23 separate House and Senate committees herein for the remainder of this 24 biennial period. In the event that one person occupies two or more of the 25 above named positions, they shall appoint a member of their house to serve as 26 their representative in one of the positions. 2.7 28 SECTION 16. Nothing in this act shall affect any statutorily created subcommittee of a joint interim committee. 29 30 SECTION 17. Arkansas Code 10-3-301(b) is amended to read as follows: 31 "(b) In order that there may be no vacancies on the Council at any 32 33 time, at the time the members are selected to the Council by the Senate and 34 by the House, there shall also be selected in the same manner, one (1) first 35 alternate member and one (1) second alternate member for each regular member.

1 First alternate members shall also be non-voting members of the Council and 2 shall be entitled to per diem and mileage for attending all meetings of the 3 Council. First alternate members of the Council shall have a vote in matters 4 before the Council if the regular member which the first alternate represents 5 is not in attendance. Second alternate members of the Council shall have a 6 vote in matters before the Council if the regular member and the first 7 alternate member which the second alternate represents are not in attendance. First alternate members attending as non-voting members of the Council shall 9 receive per diem and mileage to be paid in the same manner and from the same source as regular members of the Council." 11 SECTION 18. Arkansas Code 10-3-403(a)(1) and (2) are amended to read 12 as follows: 13 "(1) Sometime before adjournment of each regular session, the Senate 14 15 shall select twelve (12) members, with three (3) to be chosen from each of 16 the four (4) congressional districts in effect on January 1, 1987, by caucus 17 of the Senators residing in their respective congressional districts. At the 18 time of selecting members, the Senate shall also select in the same manner 19 one first alternate and one second alternate for each member selected and the 20 first alternate shall also be non-voting members of the Committee and shall 21 be entitled to receive per diem and mileage for attending all meetings of the 22 Committee. First alternate members of the Committee shall have a vote in 23 matters before the committee if the regular member which the first alternate 24 represents is not in attendance. Second alternate members of the Committee 25 shall have a vote in matters before the Committee if the regular member and 26 first alternate member which the second alternate represents are not in First alternate members attending as non-voting members of the 27 attendance. 28 committee shall receive per diem and mileage to be paid in the same manner and from the same source as regular members of the committee. The House of Representatives shall select twenty (20) members in 30 31 accordance with the procedure prescribed by House Rules. At the time of 32 selecting members, the House shall also select in the same manner one first 33 alternate and one second alternate for each member selected and the first 34 alternates shall also be non-voting members of the Committee and shall be 35 entitled to receive per diem and mileage for attending all meetings of the

1 Committee. First alternate members of the Committee shall have a vote in 2 matters before the committee if the regular member which the first alternate 3 represents is not in attendance. Second alternate members of the Committee 4 shall have a vote in matters before the Committee if the regular member and 5 first alternate member which the second alternate represents are not in 6 attendance. First alternate members attending as non-voting members of the 7 committee shall receive per diem and mileage to be paid in the same manner 8 and from the same source as regular members of the committee." 9 SECTION 19. Arkansas Code 10-3-502(b) and (c) are amended to read as 10 follows: "(b) The House shall select the members and their alternates in 12 13 accordance with the procedure prescribed by House Rules. The first alternate 14 members shall also be non-voting members of the Committee and shall be 15 entitled to receive per diem and mileage for attending meetings of the 16 Committee. First alternate members of the Committee shall have a vote in 17 matters before the Committee if a regular member which the first alternate 18 represents is not in attendance. Second alternate members of the Committee 19 shall have a vote in matters before the Committee if a regular member and a 20 first alternate member which the second alternate represents are not in 21 attendance. (c) The Senate members of the Joint Budget Committee shall be selected 2.2 23 as follows: Five (5) members from each congressional district as they 24 existed on March 1, 1991, based on seniority within the Senate. One (1) 25 Senate alternate member shall be selected from each congressional district. 26 Alternate members shall also be non-voting members of the Committee and shall 27 be entitled to receive per diem and mileage for attending meetings of the 28 Committee. First alternate members attending as non-voting members of the 29 committee shall receive per diem and mileage to be paid in the same manner 30 and from the same source as regular members of the committee." 31 Section 21 of Act 1312 of 1995 is amended to read as 32 SECTION 20. follows: 33 "Section 21. In the event that an elected constitutional officer 34 35 relocates his/her office and related staff from the State Capitol Building,

1 and does not have authorized in his/her biennial appropriation act an amount 2 sufficient to pay the moving costs, rent, costs of making necessary 3 modifications to the rented space, or other costs associated with the move, 4 the Bureau of Legislative Research of the Arkansas Legislative Council may 5 expend from appropriations authorized for the Bureau such additional funds as 6 may be required to assist such elected constitutional officer in paying the 7 additional costs. The Secretary of State and the Joint Interim Committee on 8 Legislative Facilities shall jointly decide who shall occupy the vacated 9 areas." 10 11 SECTION 21. All provisions of this act of a general and permanent 12 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 13 Code Revision Commission shall incorporate the same in the Code. 14 15 16 SECTION 22. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect 18 other provisions or applications of the act which can be given effect without 19 the invalid provision or application, and to this end the provisions of this 20 act are declared to be severable. 21 22 All laws and parts of laws in conflict with this act are 23 hereby repealed. 2.4 25 SECTION 24. EMERGENCY. It is hereby found and determined by the 26 General Assembly that the current law relating to the operation of interim committees of the General Assembly unduly restricts the interim work of the 28 General Assembly by authorizing committees to meet only as joint committees 29 of the House of Representatives and the Senate; that in order to enable the 30 Senate and House of Representatives to efficiently and effectively perform 31 their interim duties, it is necessary that the interim committees of each 32 house be authorized to meet either jointly or separately and that this act 33 should be given effect immediately to accomplish this purpose. Therefore, an 34 emergency is hereby declared to exist and this act being necessary for the 35 preservation of the public peace, health and safety shall be in full force
