8 "AN ACT TO ASSIST IN DEFRAYING THE COST OF A MULTI-PURPOSE
9 CIVIC CENTER IN SEBASTIAN COUNTY; AND FOR OTHER PURPOSES."

11 Subtitle

12 "AN ACT TO ASSIST IN DEFRAYING THE COST
13 OF A MULTI-PURPOSE CIVIC CENTER IN
14 SEBASTIAN COUNTY."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17

18 SECTION 1. Effective January 1, 1996, upon certification that monies
19 have been appropriated by local governments, set aside and committed by an
20 institution of higher education, or received by private donations, the Chief
21 Fiscal Officer of the State may release funds appropriated for defraying the
22 cost of a multi-purpose civic center in Sebastian County from time to time on
23 a dollar for dollar basis to the entities enumerated herein, to be used for
24 the purposes described herein, provided that a cooperative agreement has been
25 entered into by a local government entity and an institution of higher
26 education located in Sebastian County.

27

28 SECTION 2. Of the appropriation provided to defray the cost of a
29 multi-purpose civic center in Sebastian County, one-half shall be in addition
30 to those projects enumerated in Section 3(A) of Act 1316 of 1995. The
31 remaining funds shall be in addition to those projects enumerated in Section
32 3(B) of Act 1316 of 1995.

33

34 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
35 Assembly that any funds disbursed under the authority of the appropriations

1 contained in this Act shall be in compliance with the stated reasons for
2 which this Act was adopted, as evidenced by the Agency Requests, Executive
3 Recommendations and Legislative Recommendations contained in the budget
4 manuals prepared by the Department of Finance and Administration, letters, or
5 summarized oral testimony in the official minutes of the Arkansas Legislative
6 Council or Joint Budget Committee which relate to its passage and adoption.

7

8 SECTION 4. CODE. All provisions of this Act of a general and
9 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and
10 the Arkansas Code Revision Commission shall incorporate the same in the Code.

11

12 SECTION 5. SEVERABILITY. If any provision of this Act or the
13 application thereof to any person or circumstance is held invalid, such
14 invalidity shall not affect other provisions or applications of the Act which
15 can be given effect without the invalid provision or application, and to this
16 end the provisions of this Act are declared to be severable.

17

18 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
19 with this Act are hereby repealed.

20

21 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
22 Eightieth General Assembly meeting in its First Extraordinary Session, that
23 the Constitution of the State of Arkansas prohibits the appropriation of
24 funds for more than a two (2) year period; that the effectiveness of this Act
25 on passage and approval is essential to the operation of the agency for which
26 the appropriations in this Act are provided, and that in the event of an
27 extension of the Regular Session, the delay in the effective date of this Act
28 beyond passage and approval could work irreparable harm upon the proper
29 administration and provision of essential governmental programs. Therefore,
30 an emergency is hereby declared to exist and this Act being necessary for the
31 immediate preservation of the public peace, health and safety shall be in
32 full force and effect upon passage and approval.
