13 WHEREAS, Mr. Ira Elisha Moore of Rison, Arkansas, died on October 15 at  
14 the age of seventy years; and

16 WHEREAS, Mr. Moore, who received his education in Rison, at Kemper  
17 Military Academy in Memphis and at the University of Arkansas at  
18 Fayetteville, was widely known for his extensive timber and farming interests  
19 in south Arkansas; and

21 WHEREAS, Mr. Moore, who was very active in church and civic affairs,  
22 was a member of the Rison Baptist Church, a member of the Board of Directors  
23 of the Arkansas School for the Deaf, a lifetime member of the Arkansas  
24 Sheriff\_s Association and a board member of the Sheriff\_s Boys and Girls  
25 Ranch, a member of the Southeast Arkansas Economic Development District and  
26 the Arkansas Soil Conservation Service; and

28 WHEREAS, the House of Representatives of the Arkansas General Assembly  
29 wishes to remember Mr. Ira Elisha Moore for his outstanding accomplishments  
30 and his many contributions to his state and community,
